- 1 A BILL FOR AN ACT relating to liens; to amend section 52-1202, Reissue
- 2 Revised Statutes of Nebraska, and section 52-1103, Revised Statutes
- 3 Cumulative Supplement, 2020; to change provisions relating to filing
- 4 and perfection of liens; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 52-1103, Revised Statutes Cumulative Supplement,  
2 2020, is amended to read:

3 52-1103 In order to be valid against subsequent lienholders, any  
4 lien created under section 52-1101 shall be filed within one hundred  
5 twenty sixty days after the last date upon which the product, machinery,  
6 or equipment was furnished or work or labor was performed under the  
7 contract, but in no event shall it have priority over prior lienholders  
8 unless prior lienholders have agreed to the contract in writing. Such  
9 lien shall attach as of the date of filing. Such lien shall be treated in  
10 all respects as an agricultural lien as provided in article 9, Uniform  
11 Commercial Code, and may be enforced in the manner and form provided for  
12 the enforcement of secured transactions as provided in article 9, Uniform  
13 Commercial Code. Effective January 1, 2015, this section applies to a  
14 lien created under section 52-1101 regardless of when the lien was  
15 created.

16 Sec. 2. Section 52-1202, Reissue Revised Statutes of Nebraska, is  
17 amended to read:

18 52-1202 (1) A lien created under section 52-1201 shall be perfected  
19 as provided in article 9, Uniform Commercial Code. Such lien shall be  
20 perfected within one hundred twenty sixty days after the last date on  
21 which (a) the seed was furnished or (b) the meter was read with respect  
22 to the electrical power or energy furnished.

23 (2) Any financing statement filed to perfect a lien created under  
24 section 52-1201 shall contain or have attached thereto (a) the name and  
25 address and the social security number or federal tax identification  
26 number of the person claiming the lien, (b) the name and address and the  
27 social security number or federal tax identification number, if known, of  
28 the person to whom the seed or electrical power or energy was furnished,  
29 (c) the contract price or reasonable value of the seed or electrical  
30 power or energy, and (d)(i) the type and amount of the seed and the date  
31 of delivery of the seed or (ii) the type and amount of the electrical

1 power or energy and the period during which such power or energy was  
2 furnished. The failure to include the social security number or federal  
3 tax identification number shall not render any filing unperfected. At the  
4 time the lien is filed, the lienholder shall send a copy to the person to  
5 whom the seed or electrical power or energy was furnished. The fee for  
6 filing, amending, or releasing the lien shall be as provided in section  
7 9-525, Uniform Commercial Code.
