- 1 A BILL FOR AN ACT relating to the Semiquincentennial Commission; to
- 2 create a commission and provide duties for the commission relating
- 3 to the United States Semiquincentennial; to provide duties for the
- 4 Governor; to create a fund; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) The Semiquincentennial Commission is created. The
2 commission shall be housed within the Nebraska State Historical Society
3 for administrative and budgetary purposes.

4 (2) The commission shall consist of seventeen members.

5 (3) The Legislature intends for the commission to include members
6 from all regions of the state, representing all major interests and a
7 diverse array of industries.

8 (4) The commission shall include the following members:

9 (a) The Director of the Nebraska State Historical Society or the
10 designee of the director, who shall serve as the chairperson;

11 (b) The Director of Economic Development or the designee of such
12 person;

13 (c) The Commissioner of Education or the designee of such person;
14 and

15 (d) The President of the University of Nebraska or the designee of
16 such person;

17 (5) The commission shall include at least one member from each of
18 the following subdivisions to be appointed by the Governor before
19 September 1, 2021:

20 (a) A Native American from a federally recognized Indian tribe, as
21 of January 1, 2021, residing within the State of Nebraska. Such member
22 shall be appointed from a list of five nominees submitted by the
23 Commission on Indian Affairs;

24 (b) An African American who is a legal resident of the State of
25 Nebraska. Such member shall be appointed from a list of five nominees
26 submitted by the Commission on African American Affairs;

27 (c) A Latino-American who is a legal resident of the State of
28 Nebraska. Such member shall be appointed from a list of five nominees
29 submitted by the Commission on Latino-Americans;

30 (d) A curator or director of a private cultural institution as
31 defined in section 58-807.01 or a professional historian;

- 1 (e) A member of the Nebraska Tourism Commission;
- 2 (f) A representative from the Nebraska Humanities Council;
- 3 (g) A legal resident of the first congressional district;
- 4 (h) A legal resident of the second congressional district; and
- 5 (i) A legal resident of the third congressional district.

6 (6) The same individual shall not fulfill the requirements of more
7 than one subdivision of subsections (4) and (5) of this section.

8 (7) No more than eight of the members shall be affiliated with the
9 same political party.

10 (8) Any vacancy on the commission of an appointed member occurring
11 after the initial appointment of members shall be filled by the Governor
12 by appointment.

13 (9) The commission shall terminate on June 30, 2027.

14 Sec. 2. (1) The Semiquincentennial Commission shall hold its first
15 meeting no later than September 1, 2022.

16 (2) The members shall select a vice-chairperson and a secretary.

17 (3) Members shall receive no compensation for the performance of
18 their duties as members of the commission, except that such members shall
19 receive reimbursement for expenses as provided in sections 81-1174 to
20 81-1177.

21 (4) The commission may employ personnel and contract for services
22 and shall remit any gifts, grants, or donations to the State Treasurer
23 for credit to the Semiquincentennial Commission Fund. The commission
24 shall expend and allocate any appropriations authorized by the
25 Legislature to carry out the purposes of the commission.

26 Sec. 3. (1) The Semiquincentennial Commission is the point of
27 contact for state and national organizations and events related to the
28 Semiquincentennial of the United States and may also seek the guidance
29 and support of any party.

30 (2) The Semiquincentennial Commission shall develop programs and
31 plans for the official observance of the two hundred fiftieth anniversary

1 of the founding of the United States, as marked by the Declaration of
2 Independence in 1776.

3 (3) The commission shall cooperate with the United States
4 Semiquincentennial Commission and various state agencies, boards,
5 commissions, departments, and political subdivisions in order to execute
6 commemorative events and to implement educational activities, events, and
7 celebrations related to the Semiquincentennial of the United States.

8 (4) The commission shall promote under-represented groups from the
9 American Revolutionary War, including, but not limited to, women,
10 American Indians, and persons of color.

11 Sec. 4. (1) The Semiquincentennial Commission Fund is created. Such
12 fund shall consist of money appropriated by the Legislature and gifts,
13 grants, or donations from any source, including federal, state, public,
14 and private sources.

15 (2) The Semiquincentennial Commission Fund shall be utilized for the
16 purpose of administering the Semiquincentennial Commission and executing
17 commemorative activities and implementing educational activities, events,
18 and celebrations related to the Semiquincentennial of the United States.

19 (3) Money received by the Semiquincentennial Commission shall be
20 remitted to the State Treasurer for credit to the Semiquincentennial
21 Commission Fund. Any money in the Semiquincentennial Commission Fund
22 available for investment shall be invested by the state investment
23 officer pursuant to the Nebraska Capital Expansion Act and the Nebraska
24 State Funds Investment Act.

25 (4)(a) The State Treasurer shall transfer the unobligated balance in
26 the Semiquincentennial Commission Fund to the Historical Society Fund on
27 June 1, 2027.

28 (b) The Semiquincentennial Commission Fund terminates on June 30,
29 2027, and the State Treasurer shall transfer any money in the fund on
30 such date to the Historical Society Fund.

31 Sec. 5. Since an emergency exists, this act takes effect when

1 passed and approved according to law.
