- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$42,060 from the
- 2 General Fund for FY2021-22 and (2) \$85,316 from the General Fund for
- 3 FY2022-23 to the Supreme Court, for Program 3, to aid in carrying out the
- 4 provisions of Legislative Bill 386, One Hundred Seventh Legislature,
- 5 First Session, 2021.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$39,278
- 8 <u>for FY2021-22 or \$79,733 for FY2022-23.</u>
- 9 Sec. 2. There is hereby appropriated (1) \$34,344 from the General
- 10 Fund for FY2021-22 and (2) \$69,662 from the General Fund for FY2022-23 to
- 11 <u>the Supreme Court, for Program 4, to aid in carrying out the provisions</u>
- 12 of Legislative Bill 386, One Hundred Seventh Legislature, First Session,
- 13 2021.
- 14 Total expenditures for permanent and temporary salaries and per
- 15 diems from funds appropriated in this section shall not exceed \$31,983
- 16 for FY2021-22 or \$64,926 for FY2022-23.
- 17 Sec. 3. There is hereby appropriated (1) \$385,138 from the General
- 18 Fund for FY2021-22 and (2) \$781,175 from the General Fund for FY2022-23
- 19 to the Supreme Court, for Program 6, to aid in carrying out the
- 20 provisions of Legislative Bill 386, One Hundred Seventh Legislature,
- 21 First Session, 2021.
- 22 Total expenditures for permanent and temporary salaries and per
- 23 diems from funds appropriated in this section shall not exceed \$358,127
- 24 <u>for FY2021-22 or \$726,998 for FY2022-23.</u>
- Sec. 4. There is hereby appropriated (1) \$315,485 from the General
- 26 <u>Fund for FY2021-22 and (2) \$639,885 from the General Fund for FY2022-23</u>
- 27 <u>to the Supreme Court, for Program 7, to aid in carrying out the</u>
- 28 provisions of Legislative Bill 386, One Hundred Seventh Legislature,
- 29 First Session, 2021.
- 30 <u>Total expenditures for permanent and temporary salaries and per</u>
- 31 diems from funds appropriated in this section shall not exceed \$292,898

- 1 <u>for FY2021-22 or \$594,584 for FY2022-23.</u>
- 2 Sec. 5. There is hereby appropriated (1) \$39,202 from the
- 3 Compensation Court Cash Fund for FY2021-22 and (2) \$80,161 from the
- 4 Compensation Court Cash Fund for FY2022-23 to the Nebraska Workers'
- 5 <u>Compensation Court, for Program 526, to aid in carrying out the</u>
- 6 provisions of Legislative Bill 386, One Hundred Seventh Legislature,
- 7 First Session, 2021.
- 8 Total expenditures for permanent and temporary salaries and per
- 9 diems from funds appropriated in this section shall not exceed \$36,332
- 10 <u>for FY2021-22 or \$73,753 for FY2022-23.</u>
- 11 Sec. 6. This act becomes operative on July 1, 2021.
- 12 Sec. 7. Since an emergency exists, this act takes effect when
- 13 passed and approved according to law.
