- A BILL FOR AN ACT relating to revenue and taxation; to amend sections
  49-801.01, 50-1209, 77-2711, 77-27,119, 77-27,144, 77-5905, and
  84-602.03, Revised Statutes Cumulative Supplement, 2020; to adopt
  the Urban Redevelopment Act; to provide tax incentives as
  prescribed; to change provisions relating to refunds of local option
  sales and use taxes; to harmonize provisions; to provide an
  operative date; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Sections 1 to 28 of this act shall be known and may be

- 2 <u>cited as the Urban Redevelopment Act.</u>
- 3 Sec. 2. For purposes of the Urban Redevelopment Act, the
- 4 definitions found in sections 3 to 18 of this act shall be used.
- 5 Sec. 3. Any term has the same meaning as used in the Nebraska
- 6 Revenue Act of 1967.
- 7 Sec. 4. <u>Base year means the year immediately preceding the year of</u>
- 8 application, except that if the year of application is 2021, the base
- 9 year is either 2019 or 2020, whichever year the applicant had the larger
- 10 <u>number of equivalent employees at the qualified location.</u>
- Sec. 5. <u>Base-year employee means any individual who was employed in</u>
- 12 <u>Nebraska and subject to the Nebraska income tax on compensation received</u>
- 13 from the taxpayer or its predecessors during the base year and who is
- 14 employed at the qualified location.
- 15 Sec. 6. Economic redevelopment area means an area in the State of
- 16 Nebraska in which:
- 17 <u>(1) The average rate of unemployment in the area during the period</u>
- 18 covered by the most recent federal decennial census or American Community
- 19 <u>Survey 5-Year Estimate by the United States Bureau of the Census is at</u>
- 20 <u>least one hundred fifty percent of the average rate of unemployment in</u>
- 21 the state during the same period; and
- 22 (2) The average poverty rate in the area is twenty percent or more
- 23 <u>for the federal census tract in the area.</u>
- 24 Sec. 7. Equivalent employees means the number of employees computed
- 25 by dividing the total hours paid in a year to employees by the product of
- 26 <u>forty times the number of weeks in a year. Only the hours paid to</u>
- 27 employees who are residents of this state shall be included in such
- 28 computation. A salaried employee who receives a predetermined amount of
- 29 <u>compensation each pay period on a weekly or less frequent basis is deemed</u>
- 30 to have been paid for forty hours per week during the pay period.
- 31 Sec. 8. <u>Investment means the value of qualified property</u>

- 1 incorporated into or used at the qualified location. For qualified
- 2 property owned by the taxpayer, the value shall be the original cost of
- 3 the property. For qualified property rented by the taxpayer, the average
- 4 net annual rent shall be multiplied by the number of years of the lease
- 5 for which the taxpayer was originally bound, not to exceed ten years. The
- 6 rental of land included in and incidental to the leasing of a building
- 7 shall not be excluded from the computation. For purposes of this section,
- 8 <u>original cost means the amount required to be capitalized for</u>
- 9 depreciation, amortization, or other recovery under the Internal Revenue
- 10 Code of 1986, as amended. Any amount, including the labor of the
- 11 <u>taxpayer</u>, that is capitalized as a part of the cost of the qualified
- 12 property or that is written off under section 179 of the Internal Revenue
- 13 Code of 1986, as amended, shall be considered part of the original cost.
- 14 Sec. 9. Nebraska statewide average hourly wage for any year means
- 15 the most recent statewide average hourly wage paid by all employers in
- 16 all counties in Nebraska as calculated by the Office of Labor Market
- 17 Information of the Department of Labor using annual data from the
- 18 Quarterly Census of Employment and Wages by October 1 of the year prior
- 19 to application. Hourly wages shall be calculated by dividing the reported
- 20 <u>average annual weekly wage by forty.</u>
- 21 Sec. 10. Number of new employees means the number of equivalent
- 22 employees that are employed at the qualified location during a year that
- 23 are in excess of the number of base-year employees.
- 24 Sec. 11. <u>Performance period means the year during which the</u>
- 25 required increases in employment and investment were met or exceeded and
- 26 <u>each year thereafter until the end of the third year after the year the</u>
- 27 required increases were met or exceeded.
- Sec. 12. Qualified location means any location in a city of the
- 29 metropolitan class or a city of the primary class that is used or will be
- 30 used by the taxpayer to conduct business activities and that is located
- 31 within an economic redevelopment area. More than one qualified location

- 1 may be part of the same project.
- 2 Sec. 13. Qualified property means any tangible property of a type
- 3 subject to depreciation, amortization, or other recovery under the
- 4 Internal Revenue Code of 1986, as amended, or the components of such
- 5 property, that will be located and used at the qualified location.
- 6 Qualified property does not include (1) aircraft, barges, motor vehicles,
- 7 railroad rolling stock, or watercraft or (2) property that is rented by
- 8 <u>the taxpayer qualifying under the Urban Redevelopment Act to another</u>
- 9 person.
- 10 Sec. 14. Ramp-up period means two years from the date the complete
- 11 <u>application was filed with the Director of Economic Development.</u>
- 12 Sec. 15. <u>Related taxpayers shall include any corporations that are</u>
- 13 part of a unitary business under the Nebraska Revenue Act of 1967 but are
- 14 <u>not part of the same corporate taxpayer, any business entities that are</u>
- 15 <u>not corporations but which would be a part of the unitary business if</u>
- 16 they were corporations, and any business entities if at least fifty
- 17 percent of such entities are owned by the same persons or related
- 18 taxpayers and family members as defined in the ownership attribution
- 19 rules of the Internal Revenue Code of 1986, as amended.
- 20 Sec. 16. <u>Taxpayer means any person subject to sales and use taxes</u>
- 21 under the Nebraska Revenue Act of 1967 and subject to withholding under
- 22 section 77-2753 and any entity that is or would otherwise be a member of
- 23 the same unitary group, if incorporated, that is subject to such sales
- 24 and use taxes and such withholding. Taxpayer does not include a political
- 25 subdivision or an organization that is exempt from income taxes under
- 26 section 501(a) of the Internal Revenue Code of 1986, as amended. For
- 27 purposes of this section, political subdivision includes any public
- 28 corporation created for the benefit of a political subdivision and any
- 29 group of political subdivisions forming a joint public agency, organized
- 30 by interlocal agreement, or utilizing any other method of joint action.
- 31 Sec. 17. Wages means the wages and other payments subject to the

1 federal medicare tax.

- 2 Sec. 18. Year means the taxable year of the taxpayer.
- 3 Sec. 19. (1) To earn the incentives set forth in the Urban

- 4 Redevelopment Act, the taxpayer shall file an application for an
- 5 <u>agreement with the Director of Economic Development.</u>
- 6 (2) The application shall:
- 7 (a) Identify the taxpayer applying for incentives;
- 8 (b) Identify the location where the new investment and employment
- 9 will occur, including documentation to show that such location is a
- 10 qualified location;
- (c) State the estimated, projected amount of new investment and the
- 12 <u>estimated</u>, <u>projected number of new equivalent employees</u>; and
- 13 (d) Include an application fee of five hundred dollars. The fee
- 14 <u>shall be remitted to the State Treasurer for credit to the Nebraska</u>
- 15 Incentives Fund.
- 16 (3) Subject to the limit in subsection (4) of this section, the
- 17 <u>director shall approve the application and authorize the total amount of</u>
- 18 incentives expected to be earned as a result of the project if he or she
- 19 is satisfied that the plan in the application defines a project that
- 20 meets the requirements established in section 20 of this act and such
- 21 requirements will be reached within the required time period.
- 22 (4) The director shall not approve further applications once the
- 23 expected incentives from the approved projects total eight million
- 24 dollars. All but one hundred dollars of the application fee shall be
- 25 refunded to the applicant if the application is not approved for any
- 26 reason.
- 27 <u>(5) Applications for incentives shall be considered in the order in</u>
- 28 which they are received.
- 29 (6) The director has ninety days to approve a complete application.
- 30 <u>(7) After approval, the taxpayer and the director shall enter into a</u>
- 31 written agreement. As part of such agreement, the taxpayer shall agree to

- 1 complete the project and the director, on behalf of the State of
- 2 Nebraska, shall designate the approved plans of the taxpayer as a project
- 3 and, in consideration of the taxpayer's agreement, agree to allow the
- 4 taxpayer to use the incentives contained in the Urban Redevelopment Act
- 5 up to the total amount that were authorized by the director at the time
- 6 of approval. The application and all supporting documentation, to the
- 7 <u>extent approved, shall be considered a part of the agreement. The</u>
- 8 agreement shall state:
- 9 (a) The levels of employment and investment required by the act for
- 10 the project;
- 11 (b) The time period under the act in which the required levels must
- 12 <u>be met;</u>
- 13 (c) The documentation the taxpayer will need to supply when claiming
- 14 <u>an incentive under the act;</u>
- 15 (d) The date the application was filed; and
- 16 (e) The maximum amount of incentives authorized.
- 17 (8) The application, the agreement, all supporting information, and
- 18 all other information reported to the Director of Economic Development
- 19 shall be kept confidential by the director, except for the name of the
- 20 <u>taxpayer</u>, the location of the project, the estimated amounts of increased
- 21 employment and investment stated in the application, the date of the
- 22 complete application, the date the agreement was signed, and the
- 23 information required to be reported by section 28 of this act. The
- 24 application, the agreement, and all supporting information shall be
- 25 provided by the director to the Department of Revenue. The director shall
- 26 disclose, to any municipalities in which project locations exist, the
- 27 approval of an application and the execution of an agreement under this
- 28 section. The Tax Commissioner shall also notify each municipality of the
- 29 amount and taxpayer identity for each refund of local option sales and
- 30 use taxes of the municipality within thirty days after the refund is
- 31 allowed or approved. Disclosures shall be kept confidential by the

municipality unless publicly disclosed previously by the taxpayer or by 1

- 2 the State of Nebraska.
- (9) There shall be no new applications for incentives filed under 3
- this section after December 31, 2031. 4
- Sec. 20. (1) A tax credit shall be allowed to any taxpayer who has 5
- an approved application pursuant to the Urban Redevelopment Act if the 6
- 7 taxpayer:
- (a) Attains a cumulative investment in qualified property of at 8
- least one hundred fifty thousand dollars and hires at least five new 9
- 10 employees at the qualified location before the end of the ramp-up period;
- 11 and
- (b) Pays a minimum qualifying wage of seventy percent of the 12
- Nebraska statewide average hourly wage to the new equivalent employees 13
- for whom tax incentives are sought under the Urban Redevelopment Act. 14
- 15 (2) A tax credit shall be allowed to any taxpayer who has an
- approved application pursuant to the Urban Redevelopment Act if the 16
- 17 taxpayer attains a cumulative investment in qualified property of at
- least fifty thousand dollars at the qualified location before the end of 18
- 19 the ramp-up period.
- (3) Subject to subsection (5) of this section, the amount of the 20
- 21 credit allowed under subsection (1) of this section shall be:
- 22 (a) Three thousand dollars for each new equivalent employee, except
- that such amount shall be increased by one thousand dollars for each 23
- 24 equivalent employee who lives in an economic redevelopment area; and
- 25 (b) Two thousand seven hundred fifty dollars for each fifty thousand
- dollars of increased investment. 26
- 27 (4) Subject to subsection (5) of this section, the amount of the
- credit allowed under subsection (2) of this section shall be five percent 28
- of the investment. 29
- (5) A taxpayer may qualify for a credit under either subsection (1) 30
- or (2) of this section, but cannot qualify for a credit under both such 31

- 1 subsections. The credit shall not exceed fifty thousand dollars. The
- 2 <u>taxpayer shall receive such credit for each year of the performance</u>
- 3 period that the taxpayer is at or above the required levels of employment
- 4 and cumulative investment.
- 5 (6) A taxpayer shall not qualify for any credits under the Urban
- 6 Redevelopment Act if the taxpayer is receiving any benefits under any
- 7 other tax incentive program offered by the State of Nebraska.
- 8 (7) A teleworker working from his or her residence shall not be
- 9 considered an equivalent employee of the taxpayer for purposes of the
- 10 Urban Redevelopment Act unless the teleworker's residence is located in
- 11 <u>the economic redevelopment area in which the taxpayer's qualified</u>
- 12 <u>location is located.</u>
- 13 Sec. 21. (1)(a) If the taxpayer acquires an existing business, the
- 14 <u>increases in investment and employment shall be computed as though the</u>
- 15 <u>taxpayer had owned the business for the entire taxable year preceding the</u>
- 16 date of application.
- 17 (b) If the taxpayer disposes of an existing business and the new
- 18 owner maintains the minimum increases in investment and employment
- 19 required to create incentives, the taxpayer shall not be required to make
- 20 any repayment under section 23 of this act solely because of the
- 21 <u>disposition of the business.</u>
- 22 (2) If the structure of a business is reorganized, the taxpayer
- 23 shall compute the increases on a consistent basis for all periods.
- 24 (3) If the taxpayer moves a business from one qualified location to
- 25 another qualified location and the business was operated in a qualified
- 26 location during the taxable year preceding the date of application, the
- 27 <u>increases in investment and employment shall be computed as though the</u>
- 28 taxpayer had operated the business at the new location for the entire
- 29 <u>taxable year preceding the date of application.</u>
- 30 (4) If the taxpayer enters into any of the following transactions,
- 31 the transaction shall be presumed to be a transaction entered into for

- 1 the purpose of generating benefits under the Urban Redevelopment Act and
- 2 <u>shall not be allowed in the computation of any benefit or the meeting of</u>
- 3 any required levels under the agreement except as specifically provided
- 4 in this subsection:
- 5 (a) The purchase or lease of any property that was previously owned
- 6 by the taxpayer who filed the application or a related taxpayer unless
- 7 the first purchase by either the taxpayer who filed the application or a
- 8 related taxpayer was first placed in service at a qualified location
- 9 after the beginning of the taxable year the application was filed;
- 10 (b) The renegotiation of any lease in existence during the taxable
- 11 year the application was filed which does not materially change any of
- 12 the terms of the lease other than the expiration date;
- 13 <u>(c) The purchase or lease of any property from a related taxpayer,</u>
- 14 except that the taxpayer who filed the application will be allowed any
- 15 benefits under the act to which the related taxpayer would have been
- 16 entitled on the purchase or lease of the property if the related taxpayer
- 17 was considered the taxpayer; and
- 18 (d) Any transaction entered into primarily for the purpose of
- 19 receiving benefits under the act which is without a business purpose and
- 20 <u>does not result in increased economic activity in the state.</u>
- 21 Sec. 22. (1) The credits allowed under section 20 of this act may
- 22 be used:
- 23 (a) To obtain a refund of sales and use taxes paid under the Local
- 24 Option Revenue Act, the Nebraska Revenue Act of 1967, the Qualified
- 25 Judgment Payment Act, and sections 13-319, 13-324, and 13-2813;
- 26 <u>(b) As a refundable income tax credit claimed on an income tax</u>
- 27 return of the taxpayer. The return need not reflect any income tax
- 28 liability owed by the taxpayer;
- 29 <u>(c) To reduce the taxpayer's income tax withholding employer or</u>
- 30 payor tax liability under section 77-2756 or 77-2757. To the extent of
- 31 the credit used, such withholding shall not constitute public funds or

- 1 state tax revenue and shall not constitute a trust fund or be owned by
- 2 the state. The use by the taxpayer of the credit shall not change the
- 3 amount that otherwise would be reported by the taxpayer to the employee
- 4 under section 77-2754 as income tax withheld and shall not reduce the
- 5 amount that otherwise would be allowed by the state as a refundable
- 6 credit on an employee's income tax return as income tax withheld under
- 7 section 77-2755. The amount of credits used against income tax
- 8 withholding shall not exceed the withholding attributable to the number
- 9 of new equivalent employees employed by the taxpayer. If the amount of
- 10 credit used by the taxpayer against income tax withholding exceeds such
- 11 <u>amount, the excess withholding shall be returned to the Department of</u>
- 12 Revenue in the manner provided in section 77-2756, such excess amount
- 13 returned shall be considered unused, and the amount of unused credits may
- 14 <u>be used as otherwise permitted in this section; and</u>
- (d) To obtain a payment from the state equal to the real property
- 16 taxes due after the year the required levels of employment and investment
- 17 were met, for real property at a qualified location that is acquired by
- 18 the taxpayer after the date the application was filed. The payment from
- 19 <u>the state shall be made only after payment of the real property taxes</u>
- 20 have been made to the county as required by law. Payments shall not be
- 21 allowed for any taxes paid on real property for which the taxes are
- 22 <u>divided under section 18-2147 or 58-507.</u>
- 23 (2) A claim for the credit may be filed quarterly for refund of the
- 24 <u>sales and use taxes paid, either directly or indirectly, after the filing</u>
- 25 of the income tax return for the taxable year in which the credit was
- 26 first allowed.
- 27 (3) Once the taxpayer attains the required levels of employment and
- 28 investment, the taxpayer shall be entitled to a refund of all sales and
- 29 use taxes paid, either directly or indirectly, under the Local Option
- 30 Revenue Act, the Nebraska Revenue Act of 1967, the Qualified Judgment
- 31 Payment Act, and sections 13-319, 13-324, and 13-2813 on the qualifying

- 1 <u>investment</u>.
- 2 (4) For purposes of subsections (2) and (3) of this section, the
- 3 taxpayer shall be deemed to have paid indirectly any sales or use taxes
- 4 paid by a contractor with a purchasing agent agreement on building
- 5 materials annexed to an improvement to real estate built for the
- 6 taxpayer. The contractor shall certify to the taxpayer the amount of the
- 7 sales and use taxes paid on the building materials, or the taxpayer, with
- 8 the permission of the Director of Economic Development and a
- 9 certification from the contractor that sales and use taxes were paid on
- 10 all building materials, may presume that fifty percent of the cost of the
- 11 <u>improvement was for building materials annexed to real estate on which</u>
- 12 <u>the tax was paid.</u>
- 13 <u>(5) Credits distributed to a partner, limited liability company</u>
- 14 member, shareholder, or beneficiary under section 25 of this act may be
- 15 used against the income tax liability of the partner, member,
- 16 shareholder, or beneficiary receiving the credits.
- 17 Sec. 23. (1) If the taxpayer fails to maintain employment and
- 18 investment levels at or above the levels required in the agreement for
- 19 the entire performance period, any refunds or reduction in tax allowed
- 20 under the Urban Redevelopment Act shall be partially recaptured from the
- 21 taxpayer. The amount of the recapture for each incentive shall be a
- 22 percentage equal to the number of years the taxpayer did not maintain the
- 23 required levels of investment or employment divided by the number of
- 24 years of the performance period, with such percentage then multiplied by
- 25 the refunds or reductions in tax allowed.
- 26 (2) Any refund or reduction in tax due, to the extent required to be
- 27 <u>recaptured, shall be deemed to be an underpayment of the tax and shall be</u>
- 28 <u>immediately due and payable. When tax incentives were received in more</u>
- 29 than one year, the incentives received in the most recent year shall be
- 30 recovered first and then the incentives received in earlier years up to
- 31 the extent of the required recapture.

- 1 (3) Notwithstanding any other limitations contained in the laws of
- 2 this state, collection of any taxes deemed to be underpayments by this
- 3 section shall be allowed for a period of three years after the end of the
- 4 performance period or three calendar years after the incentive was
- 5 allowed, whichever is later.
- 6 (4) The recapture required by this section shall not occur if the
- 7 failure to maintain the required levels of employment or investment was
- 8 <u>caused by an act of God or a national emergency.</u>
- 9 Sec. 24. (1) The Director of Economic Development shall not approve
- 10 or grant to any person any tax incentive under the Urban Redevelopment
- 11 Act unless the taxpayer provides evidence satisfactory to the director
- 12 <u>that the taxpayer electronically verified the work eligibility status of</u>
- 13 <u>all newly hired employees employed in Nebraska.</u>
- 14 (2) For purposes of calculating any tax incentive available under
- 15 the act, the director shall exclude hours worked and compensation paid to
- 16 <u>an employee that is not eligible to work in Nebraska as verified under</u>
- 17 subsection (1) of this section.
- 18 Sec. 25. <u>The incentives allowed under the Urban Redevelopment Act</u>
- shall not be transferable except in the following situations:
- 20 (1) Any credit allowable to a partnership, a limited liability
- 21 company, a subchapter S corporation, a cooperative, including a
- 22 cooperative exempt under section 521 of the Internal Revenue Code of
- 23 1986, as amended, a limited cooperative association, or an estate or
- 24 trust may be distributed to the partners, limited liability company
- 25 members, shareholders, patrons, limited cooperative association members,
- 26 or beneficiaries. Any credit distributed shall be distributed in the same
- 27 manner as income is distributed. A credit distributed shall be considered
- 28 a credit used and the partnership, limited liability company, subchapter
- 29 S corporation, cooperative, limited cooperative association, estate, or
- 30 trust shall be liable for any repayment under section 23 of this act;
- 31 (2) The incentives previously allowed and the future allowance of

- 1 incentives may be transferred when a project covered by an agreement is
- 2 <u>transferred by sale or lease to another taxpayer or in an acquisition of</u>
- 3 assets qualifying under section 381 of the Internal Revenue Code of 1986,
- 4 as amended. The acquiring taxpayer, as of the date of notification of the
- 5 Director of Economic Development of the completed transfer, shall be
- 6 entitled to any unused credits and to any future incentives allowable
- 7 under the act. The acquiring taxpayer shall be liable for any repayment
- 8 that becomes due after the date of the transfer with respect to any
- 9 benefits received either before or after the transfer; and
- 10 (3) If a taxpayer allowed a credit under section 20 of this act dies
- 11 and there is credit remaining after the filing of the final return for
- 12 the taxpayer, the personal representative shall determine the
- 13 <u>distribution of the credit with the initial fiduciary return filed for</u>
- 14 the estate. The determination of the distribution of the credit may be
- 15 changed only after obtaining the permission of the director.
- 16 Sec. 26. Interest shall not be allowable on any refunds paid
- 17 because of benefits earned under the Urban Redevelopment Act.
- 18 Sec. 27. (1) The taxpayer may request the Tax Commissioner to
- 19 review and certify the taxpayer's base year employment levels. Upon a
- 20 request for such review, the Tax Commissioner shall be given access to
- 21 the employment and business records of the taxpayer and must complete the
- 22 review within ninety days after the request. If the Tax Commissioner
- 23 requests, by mail or by electronic means, additional information or
- 24 clarification from the taxpayer in order to make his or her
- 25 determination, the ninety-day period shall be tolled from the time the
- 26 Tax Commissioner makes the request to the time he or she receives the
- 27 requested information or clarification from the taxpayer. The taxpayer
- 28 and the Tax Commissioner may also agree to extend the ninety-day period.
- 29 If the Tax Commissioner fails to make his or her determination within the
- 30 prescribed ninety-day period, the certification is deemed approved.
- 31 (2) Upon review, the Tax Commissioner may approve or amend the

- 1 taxpayer's base year employment levels based upon the employment and
- 2 <u>business</u> records provided by the taxpayer. Once the Tax Commissioner
- 3 certifies the employment levels, the certification is binding on the
- 4 Department of Revenue when the taxpayer claims benefits on a return to
- 5 the extent the information provided by the taxpayer was accurate and to
- 6 the extent such information is not affected by any of the situations
- 7 described in section 21 of this act.
- 8 (3) If the taxpayer does not request review and certification of
- 9 employment levels under this section, such levels are subject to later
- 10 audit by the Department of Revenue.
- 11 Sec. 28. (1) On or before July 15, 2024, and on or before July 15
- 12 of each year thereafter, the Director of Economic Development shall
- 13 prepare a report that includes:
- 14 (a) The total amount of investment at qualified locations in the
- 15 previous calendar year by taxpayers who are receiving incentives pursuant
- 16 to the Urban Redevelopment Act;
- 17 (b) The total number of equivalent employees added in the previous
- 18 calendar year by taxpayers who are receiving incentives pursuant to the
- 19 act; and
- 20 (c) The total amount of credits claimed and refunds approved in the
- 21 previous calendar year under the act.
- 22 (2) The report shall also provide information on project-specific
- 23 total incentives used every two years for each approved project,
- 24 including (a) the identity of the taxpayer, (b) the qualified location of
- 25 the project, and (c) the total credits used and refunds approved during
- 26 the immediately preceding two years expressed as a single, aggregated
- 27 <u>total. The incentive information required to be reported under this</u>
- 28 subsection shall not be reported for the first year the taxpayer attains
