- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. The following sums of money, or so much thereof as may
- 2 <u>be required</u>, are hereby appropriated from the General Fund or from other
- 3 funds as indicated in the state treasury, not otherwise appropriated, for
- 4 the payment of indemnification claims which have been settled by the
- 5 State Claims Board and approved by the district court, which have been
- 6 settled by the Attorney General in the district court, or in which court
- 7 judgments have been entered and which require the approval of the
- 8 <u>Legislature for payment.</u>

- 17 authorized and directed to draw his or her warrants upon the funds in the
- 18 state treasury enumerated in this act, in favor of the several
- 19 <u>beneficiaries named in this act for the amount set opposite their</u>
- 20 <u>respective names, upon the presentation of proper vouchers therefor. The</u>
- 21 <u>several amounts appropriated in this act shall be in full payment of any</u>
- 22 <u>and all claims, rights, causes of action, damages, and demands of every</u>
- 23 <u>character and kind owing by or against the State of Nebraska, its</u>
- 24 officers, agents, and employees, and their successors and assigns with
- 25 respect to each of the beneficiaries respectively in whose favor the
- 26 <u>appropriations are made. The director shall not deliver any warrant for</u>
- 27 any items appropriated in this act until a receipt and release in full,
- 28 releasing the State of Nebraska, its officers, employees, and agents, and
- 29 their successors and assigns, has been filed by each of the beneficiaries
- 30 respectively. Upon presentation of the warrants, the State Treasurer is
- 31 <u>hereby directed to pay the same out of money in the General Fund or out</u>

- 1 of money in other funds indicated in this act not otherwise appropriated.
