1 A BILL FOR AN ACT relating to schools; to amend sections 79-528 and
2 79-1003, Revised Statutes Cumulative Supplement, 2020; to change
3 reporting requirements; to define and redefine terms; to include
4 virtual school students in the calculation of aid under the Tax
5 Equity and Educational Opportunities Support Act; to harmonize
6 provisions; and to repeal the original sections.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-528, Revised Statutes Cumulative Supplement,
2 2020, is amended to read:

3 79-528 (1)(a) On or before July 20 in all school districts, the
4 superintendent shall file with the State Department of Education a report
5 showing the number of children from five through eighteen years of age
6 belonging to the school district according to the census taken as
7 provided in sections 79-524 and 79-578.

8 (b) The board of any district neglecting to take and report the
9 enumeration shall be liable to the school district for all school money
10 which such district may lose by such neglect.

11 (2) On or before June 30 the superintendent of each school district
12 shall file with the Commissioner of Education a report described as an
13 end-of-the-school-year annual statistical summary showing (a) the number
14 of children attending school during the year under five years of age, (b)
15 the length of time the school has been taught during the year by a
16 qualified teacher, (c) the length of time taught by each substitute
17 teacher, (d) the number of classes a student is required to enroll in for
18 full-time enrollment in the district at each grade level for the school
19 year, (e) the definition of a class used by the district for the purpose
20 of determining full-time and part-time enrollment at each grade level for
21 the school year, (f) the number of classes completed by each virtual
22 school student as defined in section 79-1003 for the school year, and (g)
23 ~~(d)~~ such other information as the Commissioner of Education directs.

24 (3) On or before November 1 the superintendent of each school
25 district shall submit to the Commissioner of Education a report described
26 as the annual financial report showing (a) (i) the amount of money
27 received from all sources during the year and the amount of money
28 expended by the school district during the year, (b) (ii) the amount of
29 bonded indebtedness, (c) (iii) such other information as shall be
30 necessary to fulfill the requirements of the Tax Equity and Educational
31 Opportunities Support Act and section 79-1114, and (d) (iv) such other

1 information as the Commissioner of Education directs.

2 (4)(a) On or before October 15 of each year, the superintendent of
3 each school district shall file with the commissioner the fall school
4 district membership report, which report shall include the number of
5 children from birth through twenty years of age enrolled in the district
6 on October 1 of a given school year. The report shall also include
7 enumerate (i) students by grade level, (ii) school district levies and
8 total assessed valuation for the current fiscal year, (iii) students
9 enrolled in the district as option students, (iv) resident students
10 enrolled in another district as option students, (v) students enrolled in
11 the district as open enrollment students, (vi) and resident students
12 enrolled in another district as open enrollment students, (vii) the
13 number of classes a student is required to enroll in for full-time
14 enrollment in the district at each grade level for such school year,
15 (viii) the definition of a class used by the district for the purpose of
16 determining full-time and part-time enrollment at each grade level for
17 such school year, (ix) the number of classes in which each virtual school
18 student as defined in section 79-1003 is enrolled on October 1 of such
19 school year, and (x) (iv) such other information as the Commissioner of
20 Education directs.

21 ~~(b) On or before October 15 of each year prior to 2017, each~~
22 ~~learning community coordinating council shall issue to the department a~~
23 ~~report which enumerates the learning community levies pursuant to~~
24 ~~subdivision (2)(b) of section 77-3442 and total assessed valuation for~~
25 ~~the current fiscal year.~~

26 (b) (e) When any school district fails to submit its fall membership
27 report by November 1, the commissioner shall, after notice to the
28 district and an opportunity to be heard, direct that any state aid
29 granted pursuant to the Tax Equity and Educational Opportunities Support
30 Act be withheld until such time as the report is received by the
31 department. In addition, the commissioner shall direct the county

1 treasurer to withhold all school money belonging to the school district
2 until such time as the commissioner notifies the county treasurer of
3 receipt of such report. The county treasurer shall withhold such money.

12 pursuant to section 79-1007.10, minus the transportation allowance,
13 special receipts allowance, poverty allowance, limited English
14 proficiency allowance, distance education and telecommunications
15 allowance, elementary site allowance, summer school allowance,
16 instructional time allowance, teacher education allowance, and focus
17 school and program allowance, (b) for school fiscal years 2016-17 through
18 2018-19, the difference of the general fund operating expenditures as
19 calculated pursuant to subdivision (23) of this section increased by the
20 cost growth factor calculated pursuant to section 79-1007.10, minus the
21 transportation allowance, special receipts allowance, poverty allowance,
22 limited English proficiency allowance, distance education and
23 telecommunications allowance, elementary site allowance, summer school
24 allowance, and focus school and program allowance, and (c) for school
25 fiscal year 2019-20 and each school fiscal year thereafter, the
26 difference of the general fund operating expenditures as calculated
27 pursuant to subdivision (23) of this section increased by the cost growth
28 factor calculated pursuant to section 79-1007.10, minus the
29 transportation allowance, special receipts allowance, poverty allowance,
30 limited English proficiency allowance, distance education and
31 telecommunications allowance, elementary site allowance, summer school

1 allowance, community achievement plan allowance, and focus school and
2 program allowance;

3 (2) Adjusted valuation means the assessed valuation of taxable
4 property of each local system in the state, adjusted pursuant to the
5 adjustment factors described in section 79-1016. Adjusted valuation means
6 the adjusted valuation for the property tax year ending during the school
7 fiscal year immediately preceding the school fiscal year in which the aid
8 based upon that value is to be paid. For purposes of determining the
9 local effort rate yield pursuant to section 79-1015.01, adjusted
10 valuation does not include the value of any property which a court, by a
11 final judgment from which no appeal is taken, has declared to be
12 nontaxable or exempt from taxation;

13 (3) Allocated income tax funds means the amount of assistance paid
14 to a local system pursuant to section 79-1005.01;

15 (4) Average daily membership means, as provided in each school
16 district's annual statistical summary pursuant to section 79-528, the
17 average daily membership for grades kindergarten through twelve
18 attributable to the local system, including as provided in each
19 district's annual statistical summary, and includes the proportionate
20 share of students enrolled in a public school instructional program on
21 less than a full-time basis;

22 (5) Base fiscal year means the first school fiscal year following
23 the school fiscal year in which the reorganization or unification
24 occurred;

25 (6) Board means the school board of each school district;

26 (7) Categorical funds means funds limited to a specific purpose by
27 federal or state law, including, but not limited to, Title I funds, Title
28 VI funds, federal vocational education funds, federal school lunch funds,
29 Indian education funds, Head Start funds, and funds from the Education
30 Innovation Fund;

31 (8) Consolidate means to voluntarily reduce the number of school

1 districts providing education to a grade group and does not include
2 dissolution pursuant to section 79-498;

3 (9) Converted contract means an expired contract that was in effect
4 for at least fifteen school years beginning prior to school year 2012-13
5 for the education of students in a nonresident district in exchange for
6 tuition from the resident district when the expiration of such contract
7 results in the nonresident district educating students, who would have
8 been covered by the contract if the contract were still in effect, as
9 option students pursuant to the enrollment option program established in
10 section 79-234;

11 (10) Converted contract option student means a student who will be
12 an option student pursuant to the enrollment option program established
13 in section 79-234 for the school fiscal year for which aid is being
14 calculated and who would have been covered by a converted contract if the
15 contract were still in effect and such school fiscal year is the first
16 school fiscal year for which such contract is not in effect;

17 (11) Department means the State Department of Education;

18 (12) District means any school district or unified system as defined
19 in section 79-4,108;

20 (13) Ensuing school fiscal year means the school fiscal year
21 following the current school fiscal year;

22 (14) Equalization aid means the amount of assistance calculated to
23 be paid to a local system pursuant to section 79-1008.01;

24 (15) Fall membership means, ~~the total membership in kindergarten~~
25 ~~through grade twelve attributable to the local system~~ as reported on the
26 fall school district membership reports for each district pursuant to
27 section 79-528, the total membership in kindergarten through grade twelve
28 attributable to the local system, including the proportionate share of
29 students enrolled in a public school instructional program on less than a
30 full-time basis;

31 (16) Fiscal year means the state fiscal year which is the period

1 from July 1 to the following June 30;

3 (a) For state aid certified pursuant to section 79-1022, the sum of
4 the product of fall membership from the school fiscal year immediately
5 preceding the school fiscal year in which the aid is to be paid
6 multiplied by the average ratio of average daily membership to fall
7 membership for the second school fiscal year immediately preceding the
8 school fiscal year in which the aid is to be paid and the prior two
9 school fiscal years plus sixty percent of the qualified early childhood
10 education fall membership plus tuitioned students from the school fiscal
11 year immediately preceding the school fiscal year in which aid is to be
12 paid minus the product of the number of students enrolled in kindergarten
13 that is not full-day kindergarten from the fall membership multiplied by
14 0.5; and

15 (b) For the final calculation of state aid pursuant to section
16 79-1065, the sum of average daily membership plus sixty percent of the
17 qualified early childhood education average daily membership plus
18 tuitioned students minus the product of the number of students enrolled
19 in kindergarten that is not full-day kindergarten from the average daily
20 membership multiplied by 0.5 from the school fiscal year immediately
21 preceding the school fiscal year in which aid was paid;

22 (18) Free lunch and free milk calculated students means, using the
23 most recent data available on November 1 of the school fiscal year
24 immediately preceding the school fiscal year in which aid is to be paid,

25 (a) for schools that did not provide free meals to all students pursuant
26 to the community eligibility provision, students who individually
27 qualified for free lunches or free milk pursuant to the federal Richard
28 B. Russell National School Lunch Act, 42 U.S.C. 1751 et seq., and the
29 federal Child Nutrition Act of 1966, 42 U.S.C. 1771 et seq., as such acts
30 and sections existed on January 1, 2015, and rules and regulations
31 adopted thereunder, plus (b) for schools that provided free meals to all

1 students pursuant to the community eligibility provision, (i) for school
2 fiscal year 2016-17, the product of the students who attended such school
3 multiplied by the identified student percentage calculated pursuant to
4 such federal provision or (ii) for school fiscal year 2017-18 and each
5 school fiscal year thereafter, the greater of the number of students in
6 such school who individually qualified for free lunch or free milk using
7 the most recent school fiscal year for which the school did not provide
8 free meals to all students pursuant to the community eligibility
9 provision or one hundred ten percent of the product of the students who
10 qualified for free meals at such school pursuant to the community
11 eligibility provision multiplied by the identified student percentage
12 calculated pursuant to such federal provision, except that the free lunch
13 and free milk students calculated for any school pursuant to subdivision
14 (18)(b)(ii) of this section shall not exceed one hundred percent of the
15 students qualified for free meals at such school pursuant to the
16 community eligibility provision;

17 (19) Free lunch and free milk student means, for school fiscal years
18 prior to school fiscal year 2016-17, a student who qualified for free
19 lunches or free milk from the most recent data available on November 1 of
20 the school fiscal year immediately preceding the school fiscal year in
21 which aid is to be paid;

22 (20) Full-day kindergarten means kindergarten offered by a district
23 for at least one thousand thirty-two instructional hours;

24 (21) General fund budget of expenditures means the total budget of
25 disbursements and transfers for general fund purposes as certified in the
26 budget statement adopted pursuant to the Nebraska Budget Act, except that
27 for purposes of the limitation imposed in section 79-1023, the general
28 fund budget of expenditures does not include any special grant funds,
29 exclusive of local matching funds, received by a district;

30 (22) General fund expenditures means all expenditures from the
31 general fund;

1 (23) General fund operating expenditures means for state aid
2 calculated for school fiscal years 2012-13 and each school fiscal year
3 thereafter, as reported on the annual financial report for the second
4 school fiscal year immediately preceding the school fiscal year in which
5 aid is to be paid, the total general fund expenditures minus (a) the
6 amount of all receipts to the general fund, to the extent that such
7 receipts are not included in local system formula resources, from early
8 childhood education tuition, summer school tuition, educational entities
9 as defined in section 79-1201.01 for providing distance education courses
10 through the Educational Service Unit Coordinating Council to such
11 educational entities, private foundations, individuals, associations,
12 charitable organizations, the textbook loan program authorized by section
13 79-734, federal impact aid, and levy override elections pursuant to
14 section 77-3444, (b) the amount of expenditures for categorical funds,
15 tuition paid, transportation fees paid to other districts, adult
16 education, community services, redemption of the principal portion of
17 general fund debt service, retirement incentive plans authorized by
18 section 79-855, and staff development assistance authorized by section
19 79-856, (c) the amount of any transfers from the general fund to any bond
20 fund and transfers from other funds into the general fund, (d) any legal
21 expenses in excess of fifteen-hundredths of one percent of the formula
22 need for the school fiscal year in which the expenses occurred, (e)(i)
23 for state aid calculated for school fiscal years prior to school fiscal
24 year 2018-19, expenditures to pay for sums agreed to be paid by a school
25 district to certificated employees in exchange for a voluntary
26 termination occurring prior to July 1, 2009, occurring on or after the
27 last day of the 2010-11 school year and prior to the first day of the
28 2013-14 school year, or, to the extent that a district has demonstrated
29 to the State Board of Education pursuant to section 79-1028.01 that the
30 agreement will result in a net savings in salary and benefit costs to the
31 school district over a five-year period, occurring on or after the first

1 day of the 2013-14 school year or (ii) for state aid calculated for
2 school fiscal year 2018-19 and each school fiscal year thereafter,
3 expenditures to pay for incentives agreed to be paid by a school district
4 to certificated employees in exchange for a voluntary termination of
5 employment for which the State Board of Education approved an exclusion
6 pursuant to subdivision (1)(h), (i), (j), or (k) of section 79-1028.01,
7 (f)(i) expenditures to pay for employer contributions pursuant to
8 subsection (2) of section 79-958 to the School Employees Retirement
9 System of the State of Nebraska to the extent that such expenditures
10 exceed the employer contributions under such subsection that would have
11 been made at a contribution rate of seven and thirty-five hundredths
12 percent or (ii) expenditures to pay for school district contributions
13 pursuant to subdivision (1)(c)(i) or (1)(d)(i) of section 79-9,113 to the
14 retirement system established pursuant to the Class V School Employees
15 Retirement Act to the extent that such expenditures exceed the school

31 pursuant to the Nebraska Revenue Act of 1967 less all nonrefundable

1 credits earned and refunds made;

2 (26) Limited English proficiency students means the number of
3 students with limited English proficiency in a district from the most
4 recent data available on November 1 of the school fiscal year preceding
5 the school fiscal year in which aid is to be paid plus the difference of
6 such students with limited English proficiency minus the average number
7 of limited English proficiency students for such district, prior to such
8 addition, for the three immediately preceding school fiscal years if such
9 difference is greater than zero;

10 (27) Local system means a unified system or a school district;

11 (28) Low-income child means (a) for school fiscal years prior to
12 2016-17, a child under nineteen years of age living in a household having
13 an annual adjusted gross income for the second calendar year preceding
14 the beginning of the school fiscal year for which aid is being calculated
15 equal to or less than the maximum household income that would allow a
16 student from a family of four people to be a free lunch and free milk
17 student during the school fiscal year immediately preceding the school
18 fiscal year for which aid is being calculated and (b) for school fiscal
19 year 2016-17 and each school fiscal year thereafter, a child under
20 nineteen years of age living in a household having an annual adjusted
21 gross income for the second calendar year preceding the beginning of the
22 school fiscal year for which aid is being calculated equal to or less
23 than the maximum household income pursuant to sections 9(b)(1) and 17(c)
24 (4) of the Richard B. Russell National School Lunch Act, 42 U.S.C.
25 1758(b)(1) and 42 U.S.C. 1766(c)(4), respectively, and sections 3(a)(6)
26 and 4(e)(1)(A) of the Child Nutrition Act of 1966, 42 U.S.C. 1772(a)(6)
27 and 42 U.S.C. 1773(e)(1)(A), respectively, as such acts and sections
28 existed on January 1, 2015, for a household of that size that would have
29 allowed the child to meet the income qualifications for free meals during
30 the school fiscal year immediately preceding the school fiscal year for
31 which aid is being calculated;

1 (29) Low-income students means the number of low-income children
2 within the district multiplied by the ratio of the formula students in
3 the district divided by the total children under nineteen years of age
4 residing in the district as derived from income tax information;

5 (30) Most recently available complete data year means the most
6 recent single school fiscal year for which the annual financial report,
7 fall school district membership report, annual statistical summary,
8 Nebraska income tax liability by school district for the calendar year in
9 which the majority of the school fiscal year falls, and adjusted
10 valuation data are available;

11 (31) Poverty students means (a) for school fiscal years prior to
12 2016-17, the number of low-income students or the number of students who
13 are free lunch and free milk students in a district plus the difference
14 of the number of low-income students or the number of students who are
15 free lunch and free milk students in a district, whichever is greater,
16 minus the average number of poverty students for such district, prior to
17 such addition, for the three immediately preceding school fiscal years if
18 such difference is greater than zero and (b) for school fiscal year
19 2016-17 and each school fiscal year thereafter, the unadjusted poverty
20 students plus the difference of such unadjusted poverty students minus
21 the average number of poverty students for such district, prior to such
22 addition, for the three immediately preceding school fiscal years if such
23 difference is greater than zero;

24 (32) Proportionate share of students enrolled in a public school
25 instructional program on less than a full-time basis means, for both
26 virtual school students and students who are not virtual school students
27 who are enrolled in a public school instructional program on less than a
28 full-time basis, (a) for the purposes of fall membership, the number of
29 classes for which such students are enrolled in a public school
30 instructional program in the school district on October 1 divided by the
31 number of classes such students would be required to enroll in for full-

1 time enrollment in the district and (b) for the purposes of average daily
2 membership, the number of classes in a public school instructional
3 program in the school district completed by such students during the
4 school year divided by the number of classes such students would have
5 been required to enroll in for full-time enrollment in the district;

6 (33) ~~(32)~~ Qualified early childhood education average daily
7 membership means the product of the average daily membership for school
8 fiscal year 2006-07 and each school fiscal year thereafter of students
9 who will be eligible to attend kindergarten the following school year and
10 are enrolled in an early childhood education program approved by the
11 department pursuant to section 79-1103 for such school district for such
12 school year multiplied by the ratio of the actual instructional hours of
13 the program divided by one thousand thirty-two if: (a) The program is
14 receiving a grant pursuant to such section for the third year; (b) the
15 program has already received grants pursuant to such section for three
16 years; or (c) the program has been approved pursuant to subsection (5) of
17 section 79-1103 for such school year and the two preceding school years,
18 including any such students in portions of any of such programs receiving
19 an expansion grant;

20 (34) ~~(33)~~ Qualified early childhood education fall membership means
21 the product of membership on October 1 of each school year of students
22 who will be eligible to attend kindergarten the following school year and
23 are enrolled in an early childhood education program approved by the
24 department pursuant to section 79-1103 for such school district for such
25 school year multiplied by the ratio of the planned instructional hours of
26 the program divided by one thousand thirty-two if: (a) The program is
27 receiving a grant pursuant to such section for the third year; (b) the
28 program has already received grants pursuant to such section for three
29 years; or (c) the program has been approved pursuant to subsection (5) of
30 section 79-1103 for such school year and the two preceding school years,
31 including any such students in portions of any of such programs receiving

1 an expansion grant;

2 (35) ~~(34)~~ Regular route transportation means the transportation of
3 students on regularly scheduled daily routes to and from the attendance
4 center;

5 (36) ~~(35)~~ Reorganized district means any district involved in a
6 consolidation and currently educating students following consolidation;

7 (37) ~~(36)~~ School year or school fiscal year means the fiscal year of
8 a school district as defined in section 79-1091;

9 (38) ~~(37)~~ Sparse local system means a local system that is not a
10 very sparse local system but which meets the following criteria:

11 (a)(i) Less than two students per square mile in the county in which
12 each high school is located, based on the school district census, (ii)
13 less than one formula student per square mile in the local system, and
14 (iii) more than ten miles between each high school attendance center and
15 the next closest high school attendance center on paved roads;

16 (b)(i) Less than one and one-half formula students per square mile
17 in the local system and (ii) more than fifteen miles between each high
18 school attendance center and the next closest high school attendance
19 center on paved roads;

20 (c)(i) Less than one and one-half formula students per square mile
21 in the local system and (ii) more than two hundred seventy-five square
22 miles in the local system; or
