- A BILL FOR AN ACT relating to the Nebraska Criminal Code; to amend sections 28-501, 28-502, 28-503, 28-504, 28-505, 28-520, 28-522, and 28-524, Reissue Revised Statutes of Nebraska; to change provisions and penalties relating to arson, trespass, and unauthorized application of graffiti; to define and redefine terms; to harmonize
- 6 provisions; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-501, Reissue Revised Statutes of Nebraska, is

- 3 28-501 For purposes of sections 28-501 to 28-524, the following
- 4 definitions apply:
- 5 (1) Human skeletal remains has the same meaning as in section
- 6 12-1204;
- 7 (2) Public safety official means an individual serving a public or
- 8 governmental agency or political subdivision in an official capacity,
- 9 with or without compensation, as either a peace officer, a firefighter,
- 10 <u>an arson investigator, an investigatory regulator, or a member of a</u>
- 11 <u>rescue squad or ambulance crew; and</u>
- 12 (3) Structure means any building of any kind, any enclosed area with
- 13 a roof, any real property and appurtenances to which the building or
- 14 enclosed area is attached, any tent or other portable building, and any
- 15 vehicle, vessel, watercraft, or aircraft.
- 16 As used in this article, unless the context otherwise requires,
- 17 building shall mean a structure which has the capacity to contain, and is
- 18 designed for the shelter of man, animals, or property, and includes
- 19 ships, trailers, sleeping cars, aircraft, or other vehicles or places
- 20 adapted for overnight accommodations of persons or animals, or for
- 21 carrying on of business therein, whether or not a person or animal is
- 22 actually present. If a building is divided into units for separate
- 23 occupancy, any unit not occupied by the defendant is a building of
- 24 another.

- 27 28-502 (1) A person commits arson in the first degree if:
- 28 (a) The person he or she intentionally sets fire to, maintains a

- 30 way of an explosion, to any structure or any property contained inside a
- 31 structure damages a building or property contained within a building by

- 1 starting a fire or causing an explosion when another person or when human
- 2 <u>skeletal remains are</u> is present in the <u>structure</u> building at the time and
- 3 either (i) (a) the actor knows that fact, or (ii) (b) the circumstances
- 4 are such as to render the presence of a person or of human skeletal
- 5 <u>remains</u> therein a reasonable probability; -
- 6 (b) (2) A person commits arson in the first degree if a fire is set,
- 7 <u>a fire is maintained, started</u> or an explosion is caused in the
- 8 perpetration of or an attempt to perpetrate any robbery, burglary, or
- 9 felony criminal mischief when another person or human skeletal remains
- 10 are is present in the structure building at the time and either (i) (a)
- 11 the actor knows that fact₇ or (ii) (b) the circumstances are such as to
- 12 render the presence of a person <u>or of human skeletal remains</u>therein a
- 13 reasonable probability; or -
- 14 <u>(c) He or she intentionally sets fire to, maintains a fire to, or</u>
- 15 <u>burns</u>, causes to be burned, or causes damage or destruction by way of an
- 16 <u>explosion</u>, to any structure, person, human skeletal remains, or item of
- 17 personal property in order to conceal the commission of a criminal
- 18 offense.
- 19 <u>(2) A violation of this section</u> (3) Arson in the first degree is a
- 20 Class II felony unless any public safety official suffers serious bodily
- 21 injury due to such violation, in which case it is a Class ID felony.

- 24 28-503 (1) A person commits arson in the second degree if such
- 25 <u>person</u> he or she intentionally:
- 26 (a) Sets fire to, maintains a fire to, burns, causes to be burned,
- 27 <u>or causes to be damaged or destroyed by way of an explosion, any</u>
- 28 structure;
- 29 <u>(b) Damages or destroys any property contained within any structure</u>
- 30 by setting a fire, maintaining a fire, burning, causing property to be
- 31 burned, or by causing an explosion; or

- 1 (c) Sets a fire, maintains a fire, or causes an explosion during the
- 2 perpetration of or an attempt to perpetrate any robbery, burglary, or
- 3 felony criminal mischief damages a building or property contained within
- 4 a building by starting a fire or causing an explosion or if a fire is
- 5 started or an explosion is caused in the perpetration of any robbery,
- 6 burglary, or felony criminal mischief.
- 7 (2) The following affirmative defenses may be introduced into
- 8 evidence upon prosecution for a violation of this section:
- 9 (a) No person other than the accused has a security or proprietary
- 10 interest in the damaged <u>structure</u> building, or, if other persons have
- 11 such interests, all of them consented to his or her conduct; or
- 12 (b) The accused's sole intent was to destroy or damage the <u>structure</u>
- 13 building for a lawful and proper purpose.
- 14 (3) A violation of this section Arson in the second degree is a
- 15 Class IIA III felony unless any public safety official suffers serious
- 16 bodily injury due to such violation, in which case it is a Class II
- 17 felony.
- 18 Sec. 4. Section 28-504, Reissue Revised Statutes of Nebraska, is
- 19 amended to read:
- 20 28-504 (1) A person commits arson in the third degree if he or she
- 21 intentionally sets fire to, maintains a fire to, burns, causes to be
- 22 burned, or by the use of any explosive, damages or destroys, or causes to
- 23 be damaged or destroyed, any property of another person without such
- 24 other person's consent. Such property shall not be contained within a
- 25 <u>structure building</u> and shall not be a building or occupied structure.
- 26 (2) <u>A violation of this section</u> Arson in the third degree is a Class
- 27 IV felony if the damages amount to one thousand five hundred dollars or
- 28 more unless any public safety official suffers serious bodily injury due
- 29 to such violation, in which case it is a Class IIIA felony.
- 30 (3) A violation of this section Arson in the third degree is a Class
- 31 I misdemeanor if the damages are five hundred dollars or more but less

- 1 than one thousand five hundred dollars unless any public safety official
- 2 <u>suffers serious bodily injury due to such violation, in which case it is</u>
- 3 <u>a Class IV felony</u>.
- 4 (4) A violation of this section Arson in the third degree is a Class
- 5 II misdemeanor if the damages are less than five hundred dollars unless
- 6 any public safety official suffers serious bodily injury due to such
- 7 violation, in which case it is a Class I misdemeanor.

- 13 <u>aid, counsel, or procure</u> who aids, counsels or procures the burning of

- 16 the person himself or of another person, if, which shall at the time of
- 17 the fire or burning, such structure or personal property is be insured by

- 28 thereof, knowing that he or she is not licensed or privileged to do so;

- 30 (b) <u>The person</u> He or she enters or remains in or on a public power
- 31 infrastructure facility knowing that he or she does not have the consent

- 3 (2) First degree criminal trespass is a Class I misdemeanor.
- 4 (3) For purposes of this section, public power infrastructure
- facility means a power plant, an electrical station or substation, or any 5
- other facility which is used by a public power supplier as defined in 6
- 7 section 70-2103 to support the generation, transmission, or distribution
- of electricity and which is surrounded by a fence or is otherwise 8
- 9 enclosed.

- (2) The premises were at the time open to members of the public and 16
- 17 the actor complied with all lawful conditions imposed on access to or
- 18 remaining in the premises; or
- 19 (3) The actor reasonably believed that the owner of the premises or
- other person empowered to license access thereto would have licensed the 20
- actor him to enter or remain; or 21
- 22 (4) The actor was in the process of navigating or attempting to
- navigate with a nonpowered vessel any stream or river in this state and 23

- 2 application of graffiti.
- 3 (2) Unauthorized application of graffiti is a Class III misdemeanor
- 4 for a first offense and a Class IV felony for a second or subsequent
- 5 offense.
- 6 (3) Upon conviction of an offense under this section, the court may,
- 7 in addition to any other punishment imposed, order any or all of the
- 8 <u>following:</u>
- 9 <u>(a) Defendant</u> the defendant to clean up, repair, or replace the
- 10 damaged property, keep the defaced property or another specified property
- in the community free of graffiti or other inscribed materials for up to
- 12 one year, or order a combination of restitution and labor $_{L}$ -
- 13 (b) Defendant (4) Upon conviction of an offense under this section,
- 14 the court may, in addition to any other punishment imposed, order the
- 15 defendant to undergo counseling; and -
- 16 (c) Suspension (5) Upon conviction of an offense under this section,
- 17 the court may, in addition to any other punishment imposed, order the
- 18 suspension of the defendant's motor vehicle operator's license for up to
- 19 one year. A copy of an abstract of the court's conviction, including an
- 20 adjudication of a juvenile, shall be transmitted to the director pursuant
- 21 to sections 60-497.01 to 60-497.04.
- 22 (4) (6) For purposes of this section, graffiti means any letter,
- 23 word, name, number, symbol, slogan, message, drawing, picture, writing,
- 24 or other mark of any kind visible to the public that is drawn, painted,
- 25 chiseled, scratched, or etched on a rock, tree, wall, bridge, fence,
- 26 gate, building, or other structure. Graffiti does not include advertising
- 27 or any other letter, word, name, number, symbol, slogan, message,
- 28 drawing, picture, writing, or other mark of any kind lawfully placed on
- 29 property by an owner of the property, a tenant of the property, or an
- 30 authorized agent for such owner or tenant.
