- 1 A BILL FOR AN ACT relating to the Public Service Commission; to amend
- 2 sections 32-509, 75-101, and 75-101.01, Reissue Revised Statutes of
- 3 Nebraska; to change the number of districts and qualifications; to
- 4 repeal the original sections; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 32-509, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 32-509 (1) Until the effective date of legislation drawing seven
- 4 districts as reflected in maps adopted by reference in section 75-101.01,
- 5 the The State of Nebraska is divided into five public service
- 6 commissioner districts as provided and described in sections 75-101.01
- 7 and 75-101.02. A candidate for the office of public service commissioner
- 8 shall meet the qualifications found in section 75-101. The commissioners
- 9 shall be elected on the partisan ballot.
- 10 (2) Each public service commissioner shall be elected for a term of
- 11 six years. One public service commissioner from public service
- 12 commissioner district number one and one public service commissioner from
- 13 public service commissioner district number three shall be elected at the
- 14 statewide general election in 1994 and each six years thereafter. One
- 15 public service commissioner from public service commissioner district
- 16 number four and one public service commissioner from public service
- 17 commissioner district number five shall be elected at the statewide
- 18 general election in 1992 and each six years thereafter. One public
- 19 service commissioner from public service commissioner district number two
- 20 shall be elected at the statewide general election in 1996 and each six
- 21 years thereafter.
- 22 Sec. 2. Section 75-101, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 24 75-101 (1) The members of the Public Service Commission shall be
- 25 resident citizens of this state, registered voters, and, if members of or
- 26 practitioners in any profession, in good standing according to the
- 27 established standards of such profession. The members of the Public
- 28 Service Commission shall be elected as provided in section 32-509. A
- 29 candidate for the office of public service commissioner shall be a
- 30 resident of the district from which he or she seeks election. Each public
- 31 service commissioner shall be a resident of the district from which he or

- 1 she is elected. Removal from the district shall cause a vacancy in the
- 2 office of public service commissioner for the unexpired term.
- 3 (2) No person shall be eligible to the office of public service
- 4 commissioner who is directly or indirectly interested in any common
- 5 carrier or jurisdictional utility in the state or out of it or who is in
- 6 any way or manner pecuniarily interested in any common carrier subject to
- 7 Chapter 75 or 86. If any commissioner becomes so interested after
- 8 election or appointment, his or her office shall become vacant, except
- 9 that if any commissioner becomes so interested otherwise than
- 10 voluntarily, he or she shall, within a reasonable time, divest himself or
- 11 herself of such interest, and failing to do so, his or her office shall
- 12 become vacant.
- 13 (3) A commissioner shall not hold any other office under the
- 14 government of the United States, of this state, or of any other state and
- 15 shall not, while such commissioner, engage in another any other
- 16 occupation regulated by the Public Service Commission.
- 17 For purposes of Chapter 75:
- 18 (a) Commission, when referring to a state agency, means the Public
- 19 Service Commission; and
- 20 (b) Commissioner means a member of the commission.
- 21 Sec. 3. Section 75-101.01, Reissue Revised Statutes of Nebraska, is
- 22 amended to read:
- 23 75-101.01 (1) Based on the 2010 Census of Population by the United
- 24 States Department of Commerce, Bureau of the Census, the State of
- 25 Nebraska is hereby divided into five public service commissioner
- 26 districts, <u>until the effective date of legislation drawing seven public</u>
- 27 <u>service commissioner districts,</u> and each public service commissioner
- 28 district shall be entitled to one member.
- 29 (2) The numbers and boundaries of the districts are designated and
- 30 established by maps identified and labeled as maps PSC11-1, PSC11-2,
- 31 PSC11-3, PSC11-4, and PSC11-5, filed with the Clerk of the Legislature,

- 1 and incorporated by reference as part of Laws 2011, LB700.
- 2 (3)(a) The Clerk of the Legislature shall transfer possession of the
- 3 maps referred to in subsection (2) of this section to the Secretary of
- 4 State on May 27, 2011.
- 5 (b) When questions of interpretation of district boundaries arise,
- 6 the maps referred to in subsection (2) of this section in possession of
- 7 the Secretary of State shall serve as the indication of the legislative
- 8 intent in drawing the district boundaries.
- 9 (c) Each election commissioner or county clerk shall obtain copies
- 10 of the maps referred to in subsection (2) of this section for the
- 11 election commissioner's or clerk's county from the Secretary of State.
- 12 (d) The Secretary of State shall also have available for viewing on
- 13 his or her web site the maps referred to in subsection (2) of this
- 14 section identifying the boundaries for the districts.
- 15 Sec. 4. Original sections 32-509, 75-101, and 75-101.01, Reissue
- 16 Revised Statutes of Nebraska, are repealed.
- 17 Sec. 5. Since an emergency exists, this act takes effect when
- 18 passed and approved according to law.
