- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$107,300 from the
- 2 General Fund for FY2021-22 and (2) \$109,028 from the General Fund for
- 3 FY2022-23 to the Attorney General, for Program 507, to aid in carrying
- 4 out the provisions of Legislative Bill 474, One Hundred Seventh
- 5 <u>Legislature</u>, First Session, 2021.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$75,000
- 8 <u>for FY2021-22 or \$76,500 for FY2022-23.</u>
- 9 Sec. 2. There is hereby appropriated \$23,000 from the General Fund
- 10 for FY2022-23 to the Department of Revenue, for Program 102, to aid in
- 11 carrying out the provisions of Legislative Bill 474, One Hundred Seventh
- 12 <u>Legislature, First Session, 2021.</u>
- 13 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 14 for state employees shall be made from funds appropriated in this
- 15 section.
- 16 Sec. 3. There is hereby appropriated \$2,340,236 from the General
- 17 Fund for FY2022-23 to the Nebraska State Patrol, for Program 100, to aid
- 18 <u>in carrying out the provisions of Legislative Bill 474, One Hundred</u>
- 19 <u>Seventh Legislature</u>, <u>First Session</u>, 2021.
- 20 <u>Total expenditures for permanent and temporary salaries and per</u>
- 21 diems from funds appropriated in this section shall not exceed \$534,889
- 22 for FY2022-23.
- 23 Sec. 4. There is hereby appropriated (1) \$741,015 from the General
- 24 Fund for FY2021-22 and (2) \$1,826,485 from the Medicinal Cannabis
- 25 Regulation Fund for FY2022-23 to the Cannabis Enforcement Department, for
- 26 Program 411, to aid in carrying out the provisions of Legislative Bill
- 27 474, One Hundred Seventh Legislature, First Session, 2021.
- 28 Total expenditures for permanent and temporary salaries and per
- 29 diems from funds appropriated in this section shall not exceed \$279,725
- 30 <u>for FY2021-22 or \$551,775 for FY2022-23.</u>
