HILGERS: Ladies and gentlemen, welcome to the George W. Norris Legislative Chamber for the sixth day of the One Hundred Seventh Legislature, First Session. Our chaplain for today is Senator Aguilar. Please rise.

As we look to govern and inspire the people of Nebraska, please speak through us by the power of your Holy Spirit. In Jesus's name, amen.

HILGERS: Thank you, Senator Aguilar. I call to order the sixth day of the One Hundred Seventh Legislature, First Session. Senators, please record your presence. Roll call. Mr. Clerk, please record.

LB323 by Senator Walz, a bill for an act relating to the Tax Equity and Educational Opportunities Support Act; to define pandemic-affected school fiscal year; change provisions related to qualified early childhood education membership; change the calculation of the summer school and transportation allowance as prescribed; changes the determination and certification dates relating to distribution of aid; certification of budget limitations as prescribed; duties of the Appropriations Committee of the Legislature; and to harmonize provisions; repeal the original sections; declare an emergency. LB324 by Senator Brandt, it's a bill for an act relating to the Nebraska Meat and Poultry Inspection Law; to define a term and alphabetize terms; provide for animal share sales as prescribed; to create the Independent Processor Assistance Program; provide duties to the Department of Agriculture; to harmonize provisions; and repeal the original sections. LB325 by Senator Albrecht, it's a bill for an act relating to the Uniform Credentialing Act; to adopt the Art Therapy Practice Act; provide powers and duties for the Board of Mental Health Practice; harmonize provisions; repeal the original sections. LB326 by Senator Slama, it's a bill for an act relating to tort claims; provide immunity for first responders operating motor vehicles as prescribed; provide immunity for claims arising from vehicular pursuits as prescribed; provide for policies and training

LB332 by Senator Wayne, a bill for an act relating to cities of the metropolitan class; change provisions relating to the election, districts, terms, number of city council members, redistricting procedures; harmonize provisions; repeal the original sections. LB333 by Senator Wayne, a bill for an act relating to treatment and corrections; to change provisions relating to possession of electronic communications devices in Department of Correctional Service facilities; authorize possession of such devices by certain officials and attorneys; define terms; harmonize provisions; repeal the original sections. LB334 by Senator Wayne, it's a bill for an act relating to treatment and corrections; provide powers and duties for the Board of Parole, Office of Probation Administration, Office of Inspector General of the Nebraska Correctional System, the Public Counsel, Division of Parole Supervision, Department of Correctional Services; change provisions relating to escape from official detention; provide for access to presentence investigation reports; transfer responsibility for certain programs to the Board of Parole; to repeal the original sections; to outright repeal Sections 83-933. LB337, Senator Kolterman, a bill for an act relating to prescription drug coverage; to adopt the Step-Therapy Reform Act; provide a duty for the Revisor of Statutes. LB338 by Senator Bostelman. It's a bill for an act relating to telecommunications and technology; change provisions relating to universal service funding for unserved or underserved exchanges; provide for community-based plans as prescribed; provide duties for the Public Service Commission; to harmonize provisions; repeal the original sections. LB339 by Senator Bostelman. It's a bill for an act relating to highways and bridges; provide for a utility coordination plan for certain contracts. LB340 by Senator Stinner, it's a bill for an act relating to the Department of Health and Human Services; to create the Medicaid nursing facilities service program. LB341 by Senator Stinner. It's a bill for an act relating to the State Settlement Cash Fund; to eliminate obsolete provisions; to repeal the original sections; declare an emergency. LB342 by Senator Stinner. LB356 by Senator Hunt. It's a bill for an act relating to public assistance; change provisions relating to disqualification of Supplemental Nutrition Assistance Program benefits as prescribed. LB357 by Senator Hunt. It's a bill for an act relating to infants and juveniles; to define terms; to state intent; to create the Nebraska Youth in Care Bill of Rights; and provide for powers and duties. LB358 by Senator Hunt. It's a bill for an act relating to the Uniform Residential Landlord and Tenant Act; amends Section 76-1439; change provisions relating to retaliatory conduct by a landlord; and to repeal the original sections. LB366, Senator Briese, a bill for the Nebraska Advantage Microenterprise Tax Credit Act; change the termination of the act; change provisions relating to tax credit amounts and reporting requirements; provide for applicability; and repeal the original sections. LB367 by Senator Briese. It's a bill for an act relating to Mechanical Amusement Device Tax Act; to define and redefine terms; to impose and levy a tax on cash devices; harmonize provisions; provide an operative date; repeal the original sections. LB368 by Senator Sanders. It's a bill for an act relating to the Auditor of Public Accounts; provide for a late fee and audit powers as prescribed. LB369, Senator Sanders, a bill for an act relating to the Auditor of Public Accounts; provide for access to working papers and audit files as prescribed; provide for a late fee and other enforcement powers.
