### **Project Status Summary by Component**

#### **Data Management and Analytics (DMA)**

This quarter, the following deliverables were completed and approved:

- Operations Release 5 was implemented on 4/3/2023.
- Release dates for Operations 6-8 were approved.

The following deliverables have been reviewed and are pending updates to reflect the current Operations state:

- Operations System Development Lifecycle
- Operations Business and Technical Operating Plan
- User Documentation
- Job Aids

Development continues for Operations Release 6 (OR6), which is scheduled for implementation on 6/26/2023.

Regular communications continue to be circulated to HIA users; notifying them of data refreshes, system outages, and issue resolution.

In a letter dated July 27, 2022, Centers for Medicare and Medicaid Services (CMS) notified DHHS that the EVV module was certified. CMS approved the State's request for certification retroactive to the implementation date of December 13, 2020. As a result, DHHS has been approved for 75 percent Federal Financial Participation (FFP) retroactive to the first day in the calendar quarter following the project implementation date. DHHS provides quarterly performance reporting to CMS in support of ongoing funding.
