Neb. Rev. Stat. 43-512.11: Report on Work and Education Report FFY 2022

The Department of Health and Human Services shall submit an annual report electronically, no later than February 1 of each year, to the Legislature regarding the effectiveness of programs established pursuant to subdivision (5)(a) of section 43-512. The report shall include, but not be limited to:

1. The number of program participants:

Per Temporary Assistance for Needy Families (TANF) federal law, work-eligible TANF cash assistance/Aid to Dependent Children (ADC) recipients must participate in a work program. Nebraska's TANF qualified work program is the Employment First (EF) program. The EF program provides temporary, transitional support for Nebraska families so that economic self-sufficiency is attained as expeditious as possible through training, education, and employment preparation.

Equus Workforce Solutions is the statewide contractor that provides EF services for ADC recipients. The objective of the EF service contractor is to provide the necessary services and supports to assist the participants in attaining their highest level of economic self-sufficiency possible through employment. The number of EF participants reported by Equus Workforce Solutions from October 1, 2021, through September 30, 2022:

- 8,270 EF participants
- 2. The number of program participants who became employed, whether such employment is full-time or part-time or subsidized or unsubsidized, and where the employment was retained for at least thirty days:

EF program data from October 1, 2021, through September 30, 2022 reported by Equus Workforce Solutions:

- 1,093 participants gained employment for less than 30 hours per week (part-time);
- 1,238 participants gained employment for 30 hours per week or more (full-time);
- 7 participants' employment was subsidized;
- 2,324 participants' employment was unsubsidized; and,
- 2,115 participants retained employment for 30 days or longer.

3. Supportive services provided to participants in the program:

EF participants can receive services to support their EF Service Plan participation. In addition, EF participants can receive up to six months of transitional supportive services if it is determined the service is necessary to retain their employment.
