Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 195 creates the Faithful Delegate to Federal Article V Convention Act. The act provides definitions procedures for election of delegates should an Article V convention be called by the United States Congress pursuant to Article V of the United States Constitution. The act provides responsibilities for the Legislature’s Committee on Committees in nominating a delegate and alternate delegate from each legislative caucus and submitting the report to the Legislature for approval.

The delegates elected must serve as the Article V Convention Committee. The act provides that service as a delegate is an additional responsibility of service as a member of the Legislature, and in section 5, the bill states that delegates shall not be compensated for their service as delegates. The act provides additional procedures, including an oath of service for delegates, provisions for the Legislature to adopt instructions for delegate actions, provisions relating to service of alternate delegates, provisions related to unauthorized votes by a delegate, provisions creating an Advisory Committee consisting of the Executive Board of the Legislative Council and the Lieutenant Governor, and the Advisory Committee’s responsibilities.

Actual expenses for delegates and alternate delegates would be required for any official duties as members of the Legislature. The actual cost and timing of the expenses is indeterminate. As an Article V convention has not been convened, there is no fiscal impact at this time.

Explanation of Estimate:

LB195 creates the Faithful Delegate to Federal Article V Convention Act. Following the calling of an Article V convention, the Legislature shall elect three (3) delegates and three (3) alternate delegates from the members of the Legislature, unless the number of delegates is changed by congress. The delegates and alternate delegates are to be reimbursed for actual expenses in the performance of their official duties. Because an Article V convention has not yet been convened and the actual number of delegates has not yet been determined, an actual cost estimate cannot be determined at this time.
