Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 20 changes provisions related to voting by restoring convicted felons' voting rights when persons have completed their sentence, including any parole term. Current statute restores these voting rights two years after sentence and parole completion.

The Secretary of State will need to change, reprint, and mail updated voter registration forms to all counties. In addition, the Secretary of State would need to modify the voter registration application and notices sent to felons in the Voter Registration System. The total cost estimate for these items is \$8,900. Both are one-time costs. There is no basis to disagree with this estimate.

The Department of Motor Vehicles will need to change the data form used and update programming of the system. The estimate for this is \$4,400 from Cash Funds and is a one-time cost. There is no basis to disagree with this estimate.

We would also need to modify the voter registration application and notices sent out to felons in the Voter Registration System, which is expected to cost \$6,400 based on a quote from our system vendor.
