Explanation of Estimate:

LB 235 proposes to amend Section 77-6832 to allow credits provided under Section 77-6831 (4) and (5) be used for payment of taxpayer sponsored childcare provided not only at the qualified location but also within one mile of the qualified location if the qualified location is located within an economic redevelopment area.

LB 235 would have minimal cost for the Department of Economic Development in the administration of the ImagiNE Nebraska Act.
