**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB299 amends §13-809 to require any joint entity created on or after this bill is enacted that involves a public school district or Educational Service Unit (ESU) to require that entity to get approval by the majority of voters on any issuance of any kind of bond. Any bond issue that has failed to get the majority votes must wait a minimum of six months before being resubmitted to be voted on again.

Currently, voter approval on bonds issued by joint entities is not required. Changing that could affect joint projects in the future but cannot be determined at this time.

**Explanation of Estimate:**

LB 299 requires any joint entity created after this bill is enacted involving a school district or educational service unit to get voter approval before issuing bonds.

Currently joint entities are not required to get voter approval to issue bonds. This change may make it harder for districts or ESU's to work together on joint projects going forward.

No fiscal impact to NDE or the State but there may be a fiscal cost to school districts or ESU's working together through a joint entity to get voter approval to issue bonds.
