LB 343 prohibits public entities from entering into any contract with a company for goods or services unless the contract includes a written certification that the company does not currently engage in, and agrees for the term of the contract not to engage in, a boycott of Israel. Public entities shall not adopt any procurement, investment, or other policy that has the effect of allowing, inducing, or requiring a person or company to boycott Israel. The bill's provisions do not apply to contracts with a value of less than one hundred thousand dollars (\$100,000) or to companies with fewer than ten (10) full-time employees.
