**Explanation of Estimate:**

LB 513 proposed to modify the public notice requirements regarding public meetings. Until January 1, 2024, in a situation where a newspaper refuses, neglects or is unable to timely publish, a public body is to post such notice on its website and in a conspicuous public place of the public body’s jurisdiction. A written record of postings is to be kept and retained as evidence of fulfillment of the requirement.

Beginning January 1, 2024, public notices would be required to be given by publishing in a newspaper of general circulation within the public body’s jurisdiction if finalized for print prior to the time and date of the meeting, posting on the newspaper’s website, if available, and posting on a statewide website established and maintained as a repository for such notices by a majority of Nebraska newspapers. If no edition of a newspaper meeting the criteria will be finalized for printing prior to the date and time of the meeting, the postings to the newspaper’s website and statewide website is sufficient.

This change would not change the Department of Administrative Services current practices, and therefore, it has no fiscal impact to the Department of Administrative Services.
