Explanation of Estimate:

LB 593 proposes to add the verbiage to the Hearing Instrument Specialist Practice Act to expand the scope of practice of an individual licensed under the Act as a Hearing Instrument Specialist to include cerumen management.

LB 593 will require 2 hours for a DHHS Program Manager II to create information for stakeholders to be posted on the website and e-mailed; 2 hours for an Administrative Technician to revise the application form; and 2 hours for an Administrative Specialist to post the information to the public website.

Regulations may need to be revised to address training standards and unprofessional conduct. This work will require 40 hours for a DHHS Program Manager II.
