LB599 amends Sec. 13-2003 (Integrated Solid Waste Management Act) to include new definitions for advanced recycling, excludes advanced recycling from the Integrated Solid Waste Management Act, and makes advanced recycling facilities eligible for capital assistance under Sec. 81-15,160.

Nebraska currently operates no advanced recycling facilities; legislation is pre-emptive and has no fiscal impact at this time. Should facilities come online, this legislation may change the distribution of grants.

Explanation of Estimate:

LB 599 revises the Integrated Solid Waste Management Act to define and exclude advanced recycling facilities from the Integrated Solid Waste Management Act provisions. Additionally, this bill adds advanced recycling facilities to the list of eligible facilities for capital assistance grants awarded from the Waste Reduction and Recycling Incentive Fund. Currently, there are no fiscal impacts for the Department of Environment and Energy.

The agency believes future fiscal impacts could occur as more information and long-term studies are gathered/made available regarding advanced recycling facility air/solid waste and biproducts.
