- 1 A BILL FOR AN ACT relating to the Constitution of the United States; to
- 2 adopt the Faithful Delegate to Federal Article V Convention Act.
- 3 Be it enacted by the people of the State of Nebraska,

1 Section 1. Sections 1 to 11 of this act shall be known and may be

- 2 <u>cited as the Faithful Delegate to Federal Article V Convention Act.</u>
- 3 Sec. 2. For purposes of the Faithful Delegate to Federal Article V
- 4 Convention Act:
- 5 <u>(1) Alternate delegate means a member of the Legislature elected as</u>
- 6 provided in section 4 of this act to represent this state as an alternate
- 7 delegate at an Article V convention;
- 8 (2) Article V convention means a convention called by the United
- 9 States Congress under Article V of the Constitution of the United States;
- 10 (3) Delegate means:
- 11 (a) A member of the Legislature elected as provided in section 4 to
- 12 represent this state as a delegate at an Article V convention; and
- 13 (b) An alternate delegate who fills a vacancy created by the removal
- 14 of a delegate or acts in place of the delegate in such delegate's absence
- 15 or incapacity;
- 16 (4) Legislative caucus means a group of legislative districts from
- 17 which members are elected to the Executive Board of the Legislative
- 18 Council as designated in subsection (1) of section 50-401.01; and
- 19 <u>(5) Unauthorized vote means a vote by a delegate at an Article V</u>
- 20 convention that:
- 21 (a) Is contrary to the instructions adopted by the Legislature in
- 22 effect at the time the vote is taken;
- 23 <u>(b) Exceeds the scope of the subject matter of the Article V</u>
- 24 convention authorized by the Legislature in the application to the United
- 25 States Congress to call the convention if the Legislature made an
- 26 application to call the convention; or
- 27 <u>(c) Exceeds the scope or subject matter of the Article V convention</u>
- 28 if the Legislature did not make an application to the United States
- 29 <u>Congress to call the convention.</u>
- 30 Sec. 3. The purpose of the Faithful Delegate to Federal Article V
- 31 Convention Act is to provide the rules and procedures necessary to create

- 1 and guide a delegation to an Article V convention and provide legislative
- 2 <u>direction relating to the election or recall of a delegate or an</u>
- 3 <u>alternate delegate, the filling of a vacancy of a delegate or an</u>
- 4 alternate delegate, and the determination of an unauthorized vote.
- 5 Sec. 4. (1) As soon as possible following the calling of an Article
- 6 <u>V convention, the Legislature shall elect delegates and alternate</u>
- 7 delegates as provided in this section.
- 8 (2) The Committee on Committees of the Legislature shall, by
- 9 majority vote of all committee members, nominate one delegate and one
- 10 alternate delegate from each legislative caucus and submit a report of
- 11 <u>the nominations to the Legislature for approval. If the Legislature does</u>
- 12 <u>not adopt the report by a majority vote of all members, the Committee on</u>
- 13 <u>Committees shall prepare another report.</u>
- 14 (3) If the number of delegates allocated to represent this state at
- 15 the Article V convention is determined by the United States Congress or
- 16 by agreement among the states to be a number other than three, the
- 17 Legislature shall elect the appropriate number of delegates and alternate
- 18 delegates.
- 19 (4) The delegates and alternate delegates elected pursuant to this
- 20 section shall constitute the Article V Convention Committee. Of the
- 21 <u>delegate committee members so elected, the Legislature shall, by a</u>
- 22 majority vote of all members, elect a committee chairperson and vice-
- 23 <u>chairperson</u>.
- 24 (5) Service as a delegate or alternate delegate by a member of the
- 25 Legislature is an additional duty of the legislative office.
- 26 (6) The Legislature shall pair each alternate delegate with a
- 27 delegate at the time of the election. In the event of a vacancy created
- 28 by the removal of a delegate or the delegate's absence or incapacity, the
- 29 paired alternate delegate shall automatically assume the role of the
- 30 paired delegate until such time as the delegate is no longer absent or
- 31 incapacitated. If a paired delegate and alternate delegate are both

1 removed, absent, or incapacitated, the Legislature shall elect a new

- 2 <u>delegate and paired alternate delegate.</u>
- 3 Sec. 5. (1) Delegates and alternate delegates shall not be
- 4 compensated for their service as delegates and alternate delegates.
- 5 (2) Delegates and alternate delegates may be reimbursed for their
- 6 <u>expenses incurred in the performance of their official duties as provided</u>
- 7 in sections 81-1174 to 81-1177.
- 8 (3)(a) A delegate or an alternate delegate shall not accept a gift
- 9 as defined in section 49-1423 from (i) any person who is required to
- 10 register as a lobbyist under the Nebraska Political Accountability and
- 11 <u>Disclosure Act, (ii) any person who is required to register as a lobbyist</u>
- 12 with any other state, or (iii) any person who is required to register and
- 13 <u>file reports of lobbying activities, contributions, and expenses with the</u>
- 14 <u>Secretary of the United States Senate or the Clerk of the United States</u>
- 15 House of Representatives.
- 16 <u>(b) Any person who knowingly and intentionally violates this</u>
- 17 subsection is guilty of a Class III misdemeanor.
- 18 Sec. 6. (1) Each delegate and alternate delegate shall take the
- 19 following oath upon election as a delegate or alternate delegate: I do
- 20 <u>solemnly swear (or affirm) that, to the best of my abilities, I will, as</u>
- 21 <u>a delegate (or alternate delegate) to the Article V convention, act</u>
- 22 according to the limits of the authority granted to me as a delegate or
- 23 alternate delegate under the Faithful Delegate to Federal Article V
- 24 Convention Act, will not consider or vote to approve an amendment to the
- 25 Constitution of the United States not authorized by the Legislature in
- 26 <u>its application to the United States Congress to call this convention or</u>
- 27 <u>an amendment outside of the scope of this convention if the Legislature</u>
- 28 did not make an application to the United States Congress to call this
- 29 convention, and will faithfully abide by and execute the instructions to
- 30 the delegates and alternate delegates adopted by the Legislature.
- 31 (2) Each delegate and alternate delegate shall file the executed

- 1 oath with the Secretary of State.
- 2 Sec. 7. (1) At the time delegates and alternate delegates are
- 3 elected under the Faithful Delegate to Federal Article V Convention Act,
- 4 the Legislature shall adopt instructions for the delegates and alternate
- 5 delegates to govern their actions at the Article V convention.
- 6 (2) The Legislature shall not adopt instructions for an Article V
- 7 convention called following the application by the Legislature to the
- 8 <u>United States Congress for the convention that authorize a delegate or</u>
- 9 alternate delegate to consider or vote to approve an amendment to the
- 10 <u>Constitution of the United States that is not authorized by the</u>
- 11 <u>Legislature in its application for the convention.</u>
- 12 <u>(3) The Legislature may amend the instructions at any time.</u>
- Sec. 8. An alternate delegate shall act in the place of the
- 14 <u>alternate delegate's paired delegate in the event of a vacancy created by</u>
- 15 the removal of the delegate or the delegate's absence or incapacity. An
- 16 <u>alternate delegate acting under this section shall be deemed the delegate</u>
- 17 for purposes of such action.
- 18 Sec. 9. (1) A delegate shall not cast an unauthorized vote. A vote
- 19 determined to be an unauthorized vote is invalid.
- 20 (2) The determination that a vote is an unauthorized vote shall only
- 21 be made by the Legislature or by the advisory committee created pursuant
- 22 to section 11 of this act when the Legislature is not in session.
- 23 (3) A delegate who casts a vote determined to be an unauthorized
- 24 vote is disqualified to continue to serve as a delegate or alternate
- 25 delegate, and the vacancy created by the disqualification shall be filled
- 26 as provided in section 4 of this act.
- 27 Sec. 10. When it is determined by the Legislature or the advisory
- 28 committee created pursuant to section 11 of this act that a delegate has
- 29 cast an unauthorized vote, the Speaker of the Legislature shall promptly
- 30 notify the Article V Convention Committee chairperson and the presiding
- 31 officer of the Article V convention that the delegate has cast an

- 1 <u>unauthorized vote and is disqualified to serve as a delegate.</u>
- 2 Sec. 11. (1) The Executive Board of the Legislative Council and the
- 3 Lieutenant Governor shall serve as the advisory committee for the Article
- 4 V Convention Committee. The chairperson of the executive board shall
- 5 serve as the chairperson of the advisory committee. If the chairperson or
- 6 any other member of the executive board is serving as a delegate or an
- 7 alternate delegate, the chairperson's or other board member's position on
- 8 the advisory committee shall be deemed vacant and the vacancy shall be
- 9 filled in the same manner as a vacancy on the executive board. The
- 10 Lieutenant Governor may cast the deciding vote in the event of a tie vote
- 11 <u>by the rest of the voting members of the advisory committee.</u>
- 12 <u>(2) If the Legislature is not in session at a regular or special</u>
- 13 <u>session while an Article V convention is convened, the members of the</u>
- 14 <u>advisory committee shall:</u>
- (a) Meet at the call of the chairperson at the State Capitol;
- 16 (b) Upon the request of a delegate or an alternate delegate, advise
- 17 the delegate or alternate delegate whether there is reason to believe
- 18 that an action or an attempt to take an action by a delegate or alternate
- 19 delegate could result in an unauthorized vote; and
- 20 <u>(c) Determine whether a vote cast by a delegate is an unauthorized</u>
- 21 <u>vote as provided in subsection (3) of this section.</u>
- 22 (3) If a vote cast by a delegate is challenged as an unauthorized
- 23 vote under the Faithful Delegate to Federal Article V Convention Act, the
- 24 advisory committee shall determine that the vote is an unauthorized vote
- 25 only if six or more members of the advisory committee vote that it was an
- 26 unauthorized vote.
- 27 (4) The advisory committee shall not take any action when the
- 28 <u>Legislature is convened in regular or special session.</u>
