KELLY: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the thirteenth day of the One Hundred Eighth Legislature, First Session. Our chaplain today is Chaplain Mike Mennard from the New Creation Community Church in Lincoln, Nebraska. He is a guest of Senator Dorn.

MIKE MENNARD: Thank you. What an honor to be here. Am I allowed to tell you you can sit or do you have to remain standing? OK. Well, as-- as said, I'm Mike Mennard. I'm the pastor of New Creation Community. It's an honor to be here. And I imagine, at least I-- I like to imagine that it's an honor for you, too, not because I'm here, but because the people of this great state, which includes me, put you here. And thank you. Thank you for what you do, because I know it's not easy. You know, Simon Peter, one of Jesus's closest friends, wrote the following words to the ever-exploding number of converts, so Peter wrote these words shortly before he, like his lord, savior and best friend, was crucified. So his words are found in his first letter, in Chapter 4, and they're old words but they still seem pertinent. Here's what he wrote. He said, be generous with the different things God gave you, passing them around so all get in on it. Let it be-- let it be God's words, if it's-- if it's your words, because if your gift is words, let it be God's words. And if it's help, let it be God's hearty help. That way, God's bright presence will be evident in everything, and he'll get all the credit as the one mighty in everything. I think that's pertinent. Let's pray. Father God, we are grateful for the honor of being here today, and may we never lose the sense of awe and duty of the work happening here. And I pray for every single senator, every single person in this building, that each one will be used by you in a way to help our state be a place where Peter's words can come true, that we can be generous in all things. And let our words be not just our words; let them be God's words and let them have grace just covering them as we deal with each other. And I pray that your spirit will be upon us, and we pray this in the name of Jesus, amen. Thank you.
