**KELLY:** Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the eighteenth day of the One Hundred Eighth Legislature, First Session. Our chaplain today is Father Ryan Lewis, St. Elizabeth Ann Church, Omaha, Nebraska, a guest of Senator Armendariz.
