KELLY: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the third day of the One Hundred Eighth Legislature, Second Session. Our chaplain today is Senator Machaela Cavanaugh. Please rise.

M. CAVANAUGH: Thank you, Mr. President. Good morning, colleagues. "Good Grief" by Amanda Gorman, Call Us What We Carry. The origin of the word "trauma" is not just "wound," but "piercing" or "turning," as blades do when finding home. Grief commands its own grammar, structured by intimacy and imagination. We often say: we are beside ourselves with grief. We can't even imagine. This means anguish can call us to envision more than what we believed was carryable or even survivable. This is to say, there does not exist a good grief. There does exist a good grief. The hurt is how we know we are alive and awake. It clears us for all the exquisite, excruciating enormities to come. We are pierced by-- new by the turning forward. All that is grave need not be burden, an anguish. Call it, instead, an anchor, grief is grounding us in its sea. Despair exists-- exits us the same way it enters-- through-- turning through the mouth. Even now conviction works strange magic on our tongues. We are built up again by what we build/find/see/say/remember/know. What we carry means we survive, it is what survives us. We have survived us. Once we were alone, now we are beside ourselves. Where we once were barbed and brutal as blades, now we can only imagine.

KELLY: Thank you, Senator Cavanaugh. Senator Bosn, you're recognized for the Pledge of Allegiance.

BOSN: Thank you. Please join me. I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

KELLY: Thank you. I call to order the third day of the One Hundred Eighth Legislature, Second Session. Senators, please record your presence. Roll call. Mr. Clerk, please record.

ASSISTANT CLERK: There is a quorum present, Mr. President.

KELLY: Thank you, Mr. Clerk. Are there any corrections for the Journal?

ASSISTANT CLERK: No corrections this morning.

KELLY: Are there any messages, reports, or announcements?

ASSISTANT CLERK: There are, Mr. President. First, an announcement. The various agency reports that have been filed electronically are available on the Legislature's website. I have a Reference Committee report referring LB821 through. And finally, Mr. President, a series of motions relating to various rules changes offered by Senator Arch. Those will be printed in the Journal.

KELLY: Senator Aguilar, you're recognized for a message.

AGUILAR: Thank you, Mr. President. I will now read an excerpt from George W. Norris at the first Unicameral legislative session. Every professional lobbyist, every professional politician, and every representative of greed and monopoly is hoping and praying that your work will be a failure. Everything that special interests can do to embarrass you and to misinterpret your actions will be attempted. On the other hand, every lover of the fellow man, every person who wants to place our state on a higher standard of efficiency, every person who is anxious to bring about improvement in our state affairs, every patriot who wants to place our government on a higher level of good, every lover of human liberty and equal justice, and every believer in the business administration of state affairs, as distinguished from political machine control, is hoping, praying, and believing that your official work will be crowned with unlimited success and to the satisfaction and approval of believers in good government everywhere. You are members of the first Legislature of Nebraska to hold your positions without any partisan political obligation to any machine, to any boss, or to any alleged political leader. Your constituents do not expect perfection. They know that it is human to err, and they do-- but they do expect to have the right and have the right to expect absolute honesty, unlimited courage, and a reasonable degree of efficiency and wisdom. The people of Nebraska will not condemn you even if they do not agree with all your official actions. We realize that honest men, patriotic men, and wise men do not always agree. In fact, disagreement on things which are not fundamental (is) an evidence of courage and independence. We expect an economical and efficient administration and, above all, an honest administration free from any partisan bias, political prejudice, or improper motives. You have an opportunity to render a service to your fellow citizens what no other legislature has ever had. I believe you will meet your responsibilities with courage and ability. Thank you.

KELLY: Thank you, Senator Aguilar. Senator Bosn would like to recognize Dr. Voigtlander of Lincoln, Nebraska, who's serving as the

ASSISTANT CLERK: Thank you, Mr. President. LB975 offered by Senator Ibach. It's a bill for the Shovel-Ready Capital Recovery and Investment Act; to redefine terms; and to repeal the original sections. LB976, offered by Senator Blood: a bill for an act relating to courts; to provide for an education and training program on child abuse and custody determination; provide powers and duties for the State Court Administrator. LB977 by Senator Blood. It's a bill for an act relating to discrimination; to prohibit discrimination based upon military or veteran status as prescribed; to transfer provisions; to define terms; to harmonize provisions; and repeal the original sections. LB978 by Senator DeBoer. It's a bill for an act relating to adoptions; to provide for adoption by a second adult person; define term; change provisions relating to consent for adoption, home studies, terminology; to eliminate obsolete provisions; harmonize provisions; repeal the original sections. LB979 by Senator DeBoer. It's a bill for an act relating to corrections and treatment; to require an annual report on active cases by the Department of Correctional Services, Office of Probation Administration, Division of Parole Supervision. LB980 by Senator McKinney: a bill for an act relating to the death penalty; change provisions relating to persons present at an execution; and to repeal the original section. LB981 by Senator Holdcroft. It's a bill for an act relating to gaming; change provisions relating to the Nebraska Lottery and Raffle Act, the Small Lottery and Raffle Act; to harmonize provisions; to eliminate provisions relating to small lotteries; repeal the original sections; and to outright repeal Section 9-510. LB982 offered by Senator Riepe. It's a bill for an act relating to public health and welfare; to provide for employment of nurse aides in intellectual and developmental disability facilities; and to repeal the original sections. LB983 by Senator John Cavanaugh. It's a bill for an act relating to criminal procedure; to provide duties and procedures relating to plea agreements and sentencing; and define term. LB984 by Senator Hardin. It's a bill for an act relating to health care; define terms; to prohibit certain actions relating to 340B entities; provide an injunction; provide severability. That's all I have at this time, Mr. President.

KELLY: Thank you, Mr. Clerk. Mr. Clerk for new bills.

ASSISTANT CLERK: LB985 offered by Senator Linehan. It's a bill for an act relating to the Nebraska Teacher Recruitment and Retention Act;

change provisions relating to grant eligibility; repeal the original sections; declare an emergency. LB986 by Senator Linehan. It's a bill for an act relating to the Teach in Nebraska Today Act; to terminate provisions relating to loan repayment assistance under the act as prescribed; provide for grants to teachers under the act; to increase the program amount limitation; harmonize provisions; repeal the original sections. It's a bill relating to the Quality Education Accountability Act; to require each public school and each approved-- [INAUDIBLE] private, denominational, parochial schools to administer an age-appropriate national assessment instrument to students in kindergarten through 12th grade each year; to require schools to submit testing data to the Department of Education; provide and change powers and duties of the State Department [SIC-- Board] of Education, State Department of Education; and harmonize provisions; repeal the original sections. LB988, offered by Senator Linehan, is a bill for an act relating to elections; provide, change, and eliminate provisions relating to elections for certain purposes; to require an election for issuance of bonds; harmonize provisions; repeal the original sections; and to declare an emergency. LB989, offered by Senator Dungan, is a bill, bill for an act relating to real property; to change and eliminate provisions related to the Real Property Appraiser Act, the Nebraska Appraisal Management Company Registration Act; provide civil and criminal immunity for the Real Property Appraiser Board; to define and redefine terms; to harmonize provisions; and repeal the original sections. LB990, [INAUDIBLE] by Senator Bostar, is a bill for an act relating to the Pharmacy Benefit Manager Licensure and Regulation Act; to define and redefine terms; to change provisions relating to the applicability of the act; [INAUDIBLE] certain acts by pharmacy benefit managers; to harmonize provisions; repeal the original sections. LB991 by Senator Bostar. It's a bill for an act relating to digital assets; to adopt the Blockchain Basics Act. LB992 by Senator Dungan. It's a bill for an act to define and redefine terms; change provisions relating to exemptions, qualification, credentials, scope of real property appraisal practice, terminology, continuing education, fees, directory of appraisers; to eliminate random fingerprint audit program; to harmonize provisions; repeal the original sections; declare an emergency. LB995 by Senator Wayne: a bill for an act relating to criminal procedure; to change provisions related to deferred judgments; and to repeal the original sections. LB996 by Senator Wayne: a bill for an act relating to treatment and corrections; provide the Department of Correctional Services shall operate county jails; provide a duty for the Judiciary Committee of the Legislature; harmonize provisions; provide an operative date; repeal the original sections. That's all I have at this time, Mr. President.

LB1008 By Senator Walz: a bill for an act relating to appropriations; to appropriate funds for the State Department of Education for grants for security-related infrastructure projects; and transfer funds as prescribed. ASSISTANT CLERK: LB1016 offered by Senator Walz. It's a bill for an act relating to developmental disability services; to eliminate a termination date; and repeal the original sections. LB1017 by Senator Bosn. It's a bill for an act relating to workers' compensation; to change the schedule of compensation for loss of the use of more than one specific part of the body from injury or illness resulting in disability as prescribed. LB1018 by Senator Holdcroft: a bill for an act relating to government; provide that positions of public employment shall not require a postsecondary degree as prescribed; to require equal consideration for wages and benefits; and define terms. It's a bill for act relating to local public health departments; to require city-county health departments to obtain the approval of the Department of Health and Human Services in issuing directed health measures; to harmonize provisions; and repeal the original sections. LB1029 by Senator Conrad. It's a bill for an act to change provisions relating to compulsory attendance relating to illness; and to repeal the original sections. LB1030, by Senator Bostelman and others, is a bill to create a working group; change the County Bridge Match Program; provide for transfer of funds; repeal the original sections; declare an emergency.
