- and use tax exemption for electricity, natural gas, propane, and

- 5 repeal the original section.

**Section 1.** Section 77-2704.13, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 77-2704.13 Sales and use taxes shall not be imposed on the gross
- 4 receipts from the sale, lease, or rental of and the storage, use, or
- 5 other consumption in this state of:
- 6 (1) Sales and purchases of electricity, coal, gas, fuel oil, diesel
- 7 fuel, tractor fuel, propane, gasoline, coke, nuclear fuel, butane, wood
- 8 as fuel, and corn as fuel when more than fifty percent of the amount
- 9 purchased is for use directly in irrigation or farming;
- 10 (2) Sales and purchases of such energy sources or fuels when more
- 11 than fifty percent of the amount purchased is for use directly in
- 12 processing, manufacturing, or refining, in the generation of electricity,
- 13 in the compression of natural gas for retail sale as a vehicle fuel, or
- 14 by any hospital. For purposes of this subdivision, processing includes
- 15 the drying and aerating of grain in commercial agricultural facilities;
- 16 and
- 17 (3) Sales and purchases of utilities including electricity, natural
- 18 gas, propane, and sewer for residential use. For purposes of this
- 19 <u>subdivision</u>, <u>residential use includes</u>, <u>but is not limited to</u>, <u>(a) use at</u>
- 20 <u>a primary residence that is an apartment where the cost of such utilities</u>
- 21 is paid as a separate line-item charge from rent and (b) use at a
- 22 commercial property where the primary use of the property is as one or
- 23 <u>more primary residences; and</u>
- 24 (4) (3) Sales and purchases of water used for irrigation of
- 25 agricultural lands and manufacturing purposes.
- 26 **Sec. 2.** This act becomes operative on January 1, 2026.
- 27 Sec. 3. Original section 77-2704.13, Reissue Revised Statutes of
- 28 Nebraska, is repealed.
