- 4 Be it enacted by the people of the State of Nebraska,

- 1 **Section 1.** There is hereby appropriated (1) \$84,428 from the
- 2 Medicaid Managed Care Excess Profit Fund and \$184,472 from federal funds
- 3 for FY2025-26 and (2) \$171,827 from the Medicaid Managed Care Excess
- 4 Profit Fund and \$365,973 from federal funds for FY2026-27 to the
- 5 Department of Health and Human Services, for Program 344, to aid in
- 6 carrying out the provisions of Legislative Bill 22, One Hundred Ninth
- 7 Legislature, First Session, 2025.
- 8 There is included in the appropriation to this program for FY2025-26
- 9 \$84,428 Cash Funds and \$184,472 federal funds for state aid, which shall
- 10 only be used for such purpose. There is included in the appropriation to
- 11 this program for FY2026-27 \$171,827 Cash Funds and \$365,973 federal funds
- 12 <u>for state aid, which shall only be used for such purpose.</u>
- 13 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 14 for state employees shall be made from funds appropriated in this
- 15 section.
- 16 Sec. 2. There is hereby appropriated (1) \$262,715 from the Medicaid
- 17 Managed Care Excess Profit Fund and \$543,985 from federal funds for
- 18 <u>FY2025-26 and (2) \$533,928 from the Medicaid Managed Care Excess Profit</u>
- 19 Fund and \$1,079,472 from federal funds for FY2026-27 to the Department of
- 20 Health and Human Services, for Program 348, to aid in carrying out the
- 21 provisions of Legislative Bill 22, One Hundred Ninth Legislature, First
- 22 Session, 2025.
- 23 There is included in the appropriation to this program for FY2025-26
