- 1 A BILL FOR AN ACT relating to municipalities; to amend section 13-522,
- 2 Reissue Revised Statutes of Nebraska, and section 13-518, Revised
- 3 Statutes Cumulative Supplement, 2024; to adopt the Aid to
- 4 Municipalities Act; to create a fund; to change provisions relating
- 5 to budget limitations; to provide a duty for the Revisor of
- 6 Statutes; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

Sections 1 to 7 of this act shall be known and may be

- 2 cited as the Aid to Municipalities Act.
- 3 Sec. 2. The purpose of the Aid to Municipalities Act is to provide
- 4 state aid to municipalities in the form of grants which may be used to
- 5 pay for infrastructure projects within the municipalities.
- 6 **Sec. 3.** For purposes of the Aid to Municipalities Act:
- 7 (1) Department means the Department of Economic Development;
- 8 (2) Infrastructure project means any of the following projects, or
- 9 any combination thereof, to be owned or operated by a municipality: Solid
- 10 waste management facilities; wastewater, storm water, and water treatment
- 11 works and systems, water distribution facilities, and water resources
- 12 projects, including, but not limited to, pumping stations, transmission
- 13 lines, and mains and their appurtenances; hazardous waste disposal
- 14 <u>systems; resource recovery systems; airports; port facilities; buildings</u>
- 15 and capital equipment used in the operations and activities of municipal
- 16 government and to provide services to the residents of the municipality;
- 17 convention and tourism facilities; redevelopment projects as defined in
- 18 <u>section 18-2103; and mass transit and other transportation systems,</u>
- 19 <u>including parking facilities and excluding public highways and bridges</u>
- 20 and municipal roads, streets, and bridges; and
- 21 (3) Municipality means any city or village in this state.
- 22 **Sec. 4.** (1) A municipality may apply for a grant under the Aid to
- 23 Municipalities Act by submitting an application to the department on a
- 24 <u>form prescribed by the department. The application shall include:</u>
- 25 (a) The amount of grant funds requested; and
- 26 (b) A description of the infrastructure projects to be funded by the
- 27 <u>grant.</u>
- 28 (2) The department shall consider applications in the order in which
- 29 they are received and may approve applications within the limits of
- 30 <u>available appropriations, except that in no case shall any grant exceed</u>
- 31 five million dollars.

1 (3) A municipality receiving a grant under this section shall use

- 2 the grant funds exclusively to:
- 3 (a) Pay for the construction, acquisition, or equipping of
- 4 infrastructure projects or portions thereof; or
- 5 (b) Pay the principal, interest, premium, and costs of issuance on
- 6 bonds issued by the municipality to finance the construction,
- 7 acquisition, or equipping of infrastructure projects or portions thereof.
- 8 (4) Grant funds received under this section shall be placed in a
- 9 separate fund and shall not be commingled with other money of the
- 10 municipality.
- 11 Sec. 5. The Aid to Municipalities Fund is created. The fund shall
- 12 be used by the department to make grants under the Aid to Municipalities
- 13 Act and to defray the administrative expenses incurred by the department
- 14 in carrying out the act. Any money in the fund available for investment
- 15 shall be invested by the state investment officer pursuant to the
- 16 Nebraska Capital Expansion Act and the Nebraska State Funds Investment
- 17 Act.
- 18 Sec. 6. It is the intent of the Legislature to appropriate fifteen
- 19 <u>million dollars each fiscal year for purposes of carrying out the Aid to</u>
- 20 <u>Municipalities Act.</u>
- 21 Sec. 7. The department may adopt and promulgate rules and
- 22 regulations to carry out the Aid to Municipalities Act.
- 23 Sec. 8. Section 13-518, Revised Statutes Cumulative Supplement,
- 24 2024, is amended to read:
- 25 13-518 For purposes of sections 13-518 to 13-522:
- 26 (1) Allowable growth means (a) for governmental units other than
- 27 community colleges, the percentage increase in taxable valuation in
- 28 excess of the base limitation established under section 77-3446, if any,
- 29 due to improvements to real property as a result of new construction,
- 30 additions to existing buildings, any improvements to real property which
- 31 increase the value of such property, and any increase in valuation due to

- 1 annexation and any personal property valuation over the prior year and
- 2 (b) for community colleges, the percentage increase in excess of the base
- 3 limitation, if any, in full-time equivalent students from the second year
- 4 to the first year preceding the year for which the budget is being
- 5 determined;
- 6 (2) Capital improvements means (a) acquisition of real property or
- 7 (b) acquisition, construction, or extension of any improvements on real
- 8 property;
- 9 (3) Governing body has the same meaning as in section 13-503, except
- 10 that for fiscal years beginning on or after July 1, 2025, such term shall
- 11 not include the governing body of any county, city, or village;
- 12 (4) Governmental unit means every political subdivision which has
- 13 authority to levy a property tax or authority to request levy authority
- 14 under section 77-3443, except that such term shall not include (a)
- 15 sanitary and improvement districts which have been in existence for five
- 16 years or less, (b) school districts, or (c) for fiscal years beginning on
- 17 or after July 1, 2025, counties, cities, or villages;
- 18 (5) Qualified sinking fund means a fund or funds maintained
- 19 separately from the general fund to pay for acquisition or replacement of
- 20 tangible personal property with a useful life of five years or more which
- 21 is to be undertaken in the future but is to be paid for in part or in
- 22 total in advance using periodic payments into the fund. The term includes
- 23 sinking funds under subdivision (13) of section 35-508 for firefighting
- 24 and rescue equipment or apparatus;
- 25 (6) Restricted funds means (a) property tax, excluding any amounts
- 26 refunded to taxpayers, (b) payments in lieu of property taxes, (c) local
- 27 option sales taxes, (d) motor vehicle taxes, (e) state aid, (f) transfers
- 28 of surpluses from any user fee, permit fee, or regulatory fee if the fee
- 29 surplus is transferred to fund a service or function not directly related
- 30 to the fee and the costs of the activity funded from the fee, (g) any
- 31 funds excluded from restricted funds for the prior year because they were

- 1 budgeted for capital improvements but which were not spent and are not
- 2 expected to be spent for capital improvements, (h) the tax provided in
- 3 sections 77-27,223 to 77-27,227 beginning in the second fiscal year in
- 4 which the county will receive a full year of receipts, and (i) any excess
- 5 tax collections returned to the county under section 77-1776. Funds
- 6 received pursuant to the nameplate capacity tax levied under section
- 7 77-6203 for the first five years after a renewable energy generation
- 8 facility has been commissioned are nonrestricted funds; and
- 9 (7) State aid means:
- 10 (a) For all governmental units, state aid paid pursuant to sections
- 11 60-3,202 and 77-3523 and reimbursement provided pursuant to section
- 12 77-1239;
- 13 (b) For municipalities, state aid to municipalities paid pursuant to
- 14 the Aid to Municipalities Act and sections 39-2501 to 39-2520, 60-3,190,
- 15 and 77-27,139.04 and insurance premium tax paid to municipalities;
- 16 (c) For counties, state aid to counties paid pursuant to sections
- 17 60-3,184 to 60-3,190, insurance premium tax paid to counties, and
- 18 reimbursements to counties from funds appropriated pursuant to section
- 19 29-3933;
- 20 (d) For community colleges, state aid to community colleges paid
- 21 pursuant to the Community College Aid Act;
- 22 (e) For educational service units, state aid appropriated under
- 23 sections 79-1241.01 and 79-1241.03; and
- 24 (f) For local public health departments as defined in section
- 25 71-1626, state aid as distributed under section 71-1628.08.
- Sec. 9. Section 13-522, Reissue Revised Statutes of Nebraska, is
- 27 amended to read:
- 28 13-522 The Auditor of Public Accounts shall prepare budget documents
- 29 to be submitted by governmental units which calculate the restricted
- 30 funds authority for each governmental unit. Each governmental unit shall
- 31 submit its calculated restricted funds authority with its budget

- 1 documents at the time the budgets are due to the Auditor of Public
- 2 Accounts. If the Auditor of Public Accounts determines from the budget
- 3 documents that a governmental unit is not complying with the budget
- 4 limits provided in sections 13-518 to 13-522, he or she shall notify the
- 5 governing body of his or her determination and shall send notification of
- 6 <u>the noncompliance to the State Treasurer and, if the governmental unit is</u>
- 7 a city or village, to the Department of Economic Development notify the
- 8 State Treasurer of the noncompliance. The State Treasurer and, if
- 9 applicable, the department shall then suspend distribution of state aid
- 10 allocated to the governmental unit until such sections are complied with.
- 11 The funds shall be held for six months until the governmental unit
- 12 complies, and if the governmental unit complies within the six-month
- 13 period, it shall receive the suspended funds, but after six months, if
- 14 the governmental unit fails to comply, the suspended funds shall be
- 15 forfeited and shall be redistributed to other recipients of the state aid
- 16 or, in the case of homestead exemption reimbursement, returned to the
- 17 General Fund.
- 18 Sec. 10. The Revisor of Statutes shall assign sections 1 to 7 of
- 19 this act to a new article in Chapter 18.
- 20 Sec. 11. Original section 13-522, Reissue Revised Statutes of
- 21 Nebraska, and section 13-518, Revised Statutes Cumulative Supplement,
- 22 2024, are repealed.
