- 1 A BILL FOR AN ACT relating to the Nebraska Liquor Control Act; to amend
- 2 sections 53-103.02, 53-103.03, and 53-103.24, Reissue Revised
- 3 Statutes of Nebraska; to redefine terms; to remove nonalcoholic beer
- 4 from regulation under the Nebraska Liquor Control Act; to harmonize
- 5 provisions; to repeal the original sections; and to outright repeal
- 6 section 53-160.02, Reissue Revised Statutes of Nebraska.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 53-103.02, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 53-103.02 (1) Alcoholic liquor includes alcohol, spirits, wine,
- 4 beer, and any liquid or solid, patented or not, containing alcohol,
- 5 spirits, wine, or beer and capable of being consumed as a beverage by a
- 6 human being. Alcoholic liquor also includes confections or candy that
- 7 contains more than one-half of one percent alcohol.
- 8 (2) The Nebraska Liquor Control Act does not apply to (a) alcohol
- 9 used in the manufacture of denatured alcohol produced in accordance with
- 10 acts of Congress and regulations adopted and promulgated pursuant to such
- 11 acts, (b) flavoring extracts, syrups, medicinal, mechanical, scientific,
- 12 culinary, or toilet preparations, or food products unfit for beverage
- 13 purposes, but the act applies to alcoholic liquor used in the
- 14 manufacture, preparation, or compounding of such products or confections
- or candy that contains more than one-half of one percent alcohol, or (c)
- 16 wine intended for use and used by any church or religious organization
- 17 for sacramental purposes, or (d) nonalcoholic beer.
- 18 Sec. 2. Section 53-103.03, Reissue Revised Statutes of Nebraska, is
- 19 amended to read:
- 20 53-103.03 (1) Beer means a beverage obtained by alcoholic
- 21 fermentation of an infusion or concoction of barley or other grain, malt,
- 22 and hops in water and includes, but is not limited to, beer, ale, stout,
- 23 lager beer, porter, near beer, flavored malt beverage, and hard cider.
- 24 (2) Beer does not include nonalcoholic beer.
- 25 Sec. 3. Section 53-103.24, Reissue Revised Statutes of Nebraska, is
- 26 amended to read:
- 27 53-103.24 <u>Nonalcoholic beer</u> <u>Near beer</u> means beer containing less
- 28 than one-half of one percent of alcohol by volume.
- 29 **Sec. 4.** Original sections 53-103.02, 53-103.03, and 53-103.24,
- 30 Reissue Revised Statutes of Nebraska, are repealed.
