- A BILL FOR AN ACT relating to state constitutional officers; to amend sections 84-201.01 and 84-721, Reissue Revised Statutes of Nebraska,
- and section 75-104, Revised Statutes Cumulative Supplement, 2024; to
- 4 change the salaries of the Lieutenant Governor, Secretary of State,
- 5 Auditor of Public Accounts, State Treasurer, Attorney General, and
- 6 members of the Public Service Commission; to harmonize provisions;
- 7 and to repeal the original sections.
- Be it enacted by the people of the State of Nebraska,

- **Section 1.** Section 75-104, Revised Statutes Cumulative Supplement,
- 2 2024, is amended to read:
- 3 75-104 (1) Until January <u>7, 2027</u> 4, 2007, the annual salary of each
- 4 commissioner shall be fifty thousand dollars. Commencing January 4, 2007,
- 5 the annual salary of each commissioner shall be seventy-five thousand
- 6 dollars. Commencing January 7, 2027, the annual salary of each
- 7 commissioner shall be XX thousand dollars.
- 8 (2) Each commissioner shall be entitled to receive from the state
- 9 his or her mileage expenses incurred while traveling in the line of duty
- 10 to and from his or her residence to the office of the Public Service
- 11 Commission in Lincoln pursuant to the following conditions:
- 12 (a) The Public Service Commission has adopted and promulgated rules
- 13 and regulations establishing guidelines for allowable reimbursement of
- 14 such mileage expenses, except that such mileage rate shall not exceed the
- 15 mileage rate established by the Department of Administrative Services
- 16 pursuant to section 81-1176;
- 17 (b) The request for such reimbursement falls within such guidelines;
- 18 and
- 19 (c) The total amounts authorized for such reimbursement of mileage
- 20 expenses in any fiscal year does not cause the total expenses to exceed
- 21 the total funds appropriated to the program established for
- 22 commissioners' expenses. In addition thereto, the commissioners,
- 23 executive director, clerks, and other employees of the commission shall
- 24 be reimbursed for expenses, including the cost of transportation while
- 25 traveling on the business of the commission, to be paid in the same
- 26 manner as other requests for payment or reimbursement from the state. In
- 27 computing the cost of transportation for the commissioners, executive
- 28 director, clerks, and other employees, no mileage or other traveling
- 29 expense shall be requested or allowed unless sections 81-1174 to 81-1177
- 30 are strictly complied with.

- 7 of the Attorney General shall be payable in equal monthly installments.
- 8 Sec. 3. Section 84-721, Reissue Revised Statutes of Nebraska, is
- 9 amended to read:
- 10 84-721 Until January <u>7, 2027</u> 4, 2007, there shall be paid as
- 11 salaries to certain constitutional officers as follows: Secretary of
- 12 State, the sum of sixty-five thousand dollars per year; Auditor of Public
- 13 Accounts, the sum of sixty thousand dollars per year; State Treasurer,
- 14 the sum of sixty thousand dollars per year; and Lieutenant Governor, the
- 15 sum of sixty thousand dollars per year. Commencing January 4, 2007, there
- 16 shall be paid as salaries to certain constitutional officers as follows:
- 17 Secretary of State, the sum of eighty-five thousand dollars per year;
- 18 Auditor of Public Accounts, the sum of eighty-five thousand dollars per
- 19 year; State Treasurer, the sum of eighty-five thousand dollars per year;
- 20 and Lieutenant Governor, the sum of seventy-five thousand dollars per
- 21 year. Commencing January 7, 2027, there shall be paid as salaries to
- 22 certain constitutional officers as follows: Secretary of State, the sum
- 23 of XX thousand dollars per year; Auditor of the Public Accounts, the sum
- 24 of XX thousand dollars per year; State Treasurer, the sum of XX thousand
- 25 dollars per year; and Lieutenant Governor, the sum of XX thousand dollars
- 26 per year. Such salaries shall be payable in equal monthly installments.
