- 6 Be it enacted by the people of the State of Nebraska,

Section 1. Section 71-6038, Reissue Revised Statutes of Nebraska, is

- 3 71-6038 For purposes of sections 71-6038 to 71-6042:
- 4 (1) Complicated feeding problems include, but are not limited to,
- 5 difficulty swallowing, recurrent lung aspirations, and tube or parenteral
- 6 or intravenous feedings;
- 7 (2) Department means the Department of Health and Human Services;
- 8 (3) Nurse aide means any person employed by a service provider or
- 9 facility described in subsection (1) of section 71-6039 for the purpose
- 10 of aiding a licensed registered or practical nurse through the
- 11 performance of nonspecialized tasks related to the personal care and
- 12 comfort of residents other than a paid dining assistant or a licensed
- 13 registered or practical nurse;
- 14 (4) Nursing home means any facility or a distinct part of any
- 15 facility that provides care as defined in sections 71-420, 71-421,
- 16 71-422, 71-424, and 71-429; and
- 17 (5) Paid dining assistant means any person employed by a nursing
- 18 home for the purpose of aiding a licensed registered or practical nurse
- 19 through the feeding of residents other than a nurse aide or a licensed
- 20 registered or practical nurse; and -
- 21 (6) Service provider means a person certified by the department to
- 22 provide developmental disabilities services.
- 23 Sec. 2. Section 71-6039, Reissue Revised Statutes of Nebraska, is

- 25 71-6039 (1) No person shall act as a nurse aide for a service
- 26 provider under the medicaid comprehensive developmental disabilities
- 27 <u>waiver for services as defined in section 71-6501, or in a facility or a</u>
- 28 distinct part of a facility that provides care as defined in section
- 29 71-405, 71-406, 71-409, 71-412, 71-416, 71-417, 71-418, 71-419, 71-420,
- 30 71-421, 71-422, 71-424, 71-426, 71-427, or 71-429 unless such person:
- 31 (a) Is at least sixteen years of age and has not been convicted of a

- 1 crime involving moral turpitude;
- 2 (b) Is able to speak and understand the English language or a
- 3 language understood by a substantial portion of the facility residents;
- 4 and
- 5 (c) Has successfully completed a basic course of training approved
- 6 by the department for nurse aides within one hundred twenty days of
- 7 initial employment in the capacity of a nurse aide.
- 8 (2)(a) A registered nurse or licensed practical nurse whose license
- 9 has been revoked, suspended, or voluntarily surrendered in lieu of
- 10 discipline may not act as a nurse aide <u>for a service provider or in a</u>
- 11 facility described in subsection (1) of this section.
- 12 (b) If a person registered as a nurse aide becomes licensed as a
- 13 registered nurse or licensed practical nurse, his or her registration as
- 14 a nurse aide becomes null and void as of the date of licensure.
- (c) A person listed on the Nurse Aide Registry with respect to whom
- 16 a finding of conviction has been placed on the registry may petition the
- 17 department to have such finding removed at any time after one year has
- 18 elapsed since the date such finding was placed on the registry.
- 19 (3) The department may prescribe a curriculum for training nurse
- 20 aides and may adopt and promulgate rules and regulations for such courses
- 21 of training. The content of the courses of training and competency
- 22 evaluation programs shall be consistent with federal requirements unless
- 23 exempted. The department may approve courses of training if such courses
- 24 of training meet the requirements of this section. Such courses of
- 25 training shall include instruction on the responsibility of each nurse
- 26 aide to report suspected abuse or neglect pursuant to sections 28-372 and
- 27 28-711. Nursing homes may carry out approved courses of training within
- 28 the nursing home, except that nursing homes may not conduct the
- 29 competency evaluation part of the program. The prescribed training shall
- 30 be administered by a licensed registered nurse.
- 31 (4) For nurse aides at intermediate care facilities for persons with

- 1 developmental disabilities, such courses of training shall be no less
- 2 than twenty hours in duration and shall include at least fifteen hours of
- 3 basic personal care training and five hours of basic therapeutic and
- 4 emergency procedure training, and for nurse aides at all nursing homes
- 5 other than intermediate care facilities for persons with developmental
- 6 disabilities, such courses shall be no less than seventy-five hours in
- 7 duration.
- 8 (5) This section shall not prohibit any facility from exceeding the
- 9 minimum hourly or training requirements.

- 11 Statutes of Nebraska, are repealed.
