1 (4)(a) Except as provided in subdivision (b) of this subsection, the identification inspection shall include examination and notation of the 2 3 then current odometer reading, if any, and a comparison of the vehicle identification number with the number listed on the ownership records, 4 5 except that if a lien is registered against a vehicle and recorded on the vehicle's ownership records, the county treasurer shall provide a copy of 6 the ownership records for use in making such comparison. If such numbers 7 8 are not identical, if there is reason to believe further inspection is 9 necessary, or if the inspection is for a Nebraska assigned number, the person performing the inspection shall make a further inspection of the 10 vehicle which may include, but shall not be limited to, examination of 11 other identifying numbers placed on the vehicle by the manufacturer and 12 an inquiry into the numbering system used by the state issuing such 13 ownership records to determine ownership of a vehicle. The identification 14 inspection shall also include a statement that the vehicle identification 15 16 number has been checked for entry in (i) the National Crime Information Center and (ii) the Nebraska Crime Information Service or the National 17 Motor Vehicle Title Information System. In the case of an assembled 18 vehicle, a vehicle designated as reconstructed, or a vehicle designated 19 as replica, the identification inspection shall include, but not be 20 limited to, an examination of the records showing the date of receipt and 21 source of each major component part. No identification inspection shall 22 23 be conducted unless all major component parts are properly attached to 24 the vehicle in the correct location.

(b) Each county sheriff shall establish a process by which to enter into an agreement with any motor vehicle dealer as defined in section 60-1401.26 with an established place of business as defined in section 60-1401.15 in the county in which the sheriff has jurisdiction in order to collect information for the identification inspection on motor vehicles which are in the inventory of the motor vehicle dealer at the dealer's established place of business in such county. The agreement

- entered into shall require that the motor vehicle dealer provide the 1 2 required fee, a copy of the documents evidencing transfer of ownership, and the make, model, vehicle identification number, and odometer reading 3 in a form and manner prescribed by the county sheriff, which shall 4 include a requirement to provide one or more photographs or digital 5 images of the vehicle, the vehicle identification number, and the 6 7 odometer reading. The county sheriff shall complete the identification inspection as required under subdivision (a) of this subsection using 8 9 such information and return to the motor vehicle dealer the statement that an identification inspection has been conducted for each motor 10 vehicle as provided in subsection (3) of this section. If the information 11 is incomplete or if there is reason to believe that further inspection is 12 necessary, the county sheriff shall inform the motor vehicle dealer. If 13 the motor vehicle dealer knowingly provides inaccurate or false 14 information, the motor vehicle dealer shall be liable for any damages 15 16 that result from the provision of such information. The motor vehicle dealer shall keep the records for five years after the date the 17 identification inspection is complete. 18
- 19 (5) If there is cause to believe that odometer fraud exists, written 20 notification shall be given to the office of the Attorney General. If 21 after such inspection the sheriff or his or her designee determines that 22 the vehicle is not the vehicle described by the ownership records, no 23 statement shall be issued.
- (6) The county treasurer or the department may also request an identification inspection of a vehicle to determine if it meets the definition of motor vehicle as defined in section 60-123.

- 1 (2) If a certificate of title of a mobile home or manufactured home 2 is surrendered to the county treasurer, along with the affidavit required by subdivision (1)(c) of this section, he or she shall enter a 3 cancellation upon his or her records, notify the department of such 4 5 cancellation, forward a duplicate original of the affidavit to the department, and deliver a duplicate original of the executed affidavit 6 7 under subdivision (1)(c) of this section to the register of deeds for the county in which the real property is located to be filed by the register 8 9 of deeds. The county treasurer shall be entitled to collect fees from the person submitting the affidavit in accordance with section 33-109 to 10 cover the costs of filing such affidavit.
