This bill would appropriate \$5,000,000 for FY2016-17 to the Department of Correctional Services. These funds shall only be used to house prison inmates at county jails where such inmates have been classified as community corrections inmates and are housed at county jails in the general area where the inmates will be located. Such county jails shall be used to facilitate work release for inmates.

For purposes of this fiscal note, FY2017-18 is used rather than FY2016-17.

The Board of Parole estimates no fiscal impact from this bill.

Douglas County estimates no fiscal impact from this bill.

The Lancaster County Department of Corrections states that they cannot determine a fiscal impact without knowing the daily rate or the number of inmates involved.
