Explanation of Estimate:

LB 988 amends the definition of consent for purposes of the crime of sexual assault to clarify that consent means words or overt actions indicating a knowing and voluntary agreement and that the absence of force, fraud or coercion, by itself, shall not constitute consent.

The fiscal impact of LB 988 on NDCS is indeterminable. The bill affects crimes committed after the effective date of the act and it is unknown how the proposed definitions will affect the reporting, prosecution, conviction or sentencing of individuals for sexual assault.
