**Explanation of Estimate:**

Under current law, certain lump sum settlement in workers compensation cases must be submitted to the Workers' Compensation Court for approval. One circumstance where a settlement must be approved by the Workers' Compensation Court is if the employee is eligible for medicare, is a medicare beneficiary, or has a reasonable expectation of becoming eligible for medicare within thirty months after the date the settlement is executed.

LB 1103 excludes this circumstance requiring Workers' Compensation Court approval if the employee's right to receive future medical, surgical, and hospital services as provided in section 48-120 is specifically excluded from the settlement.

There is no fiscal impact.
