Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

All but one provision of LB277 have no fiscal impact. The single provision requires any deposit being returned to a former tenant, under the provisions of the Mobile Home Landlord and Tenant Act, which remains outstanding after 30 days of the date of mailing or returned as undeliverable, to be remitted to the State Treasurer for disposition pursuant to the Uniform Disposition of Unclaimed Property Act.

The State Treasurer may see an increase in the quantity of work due to the potential for outstanding deposits being required to be remitted to their office. However, based on previous responses for similar bills it is anticipated any increase would be able to be accommodated within their existing appropriation.

The Supreme Court indicates there would be minimal fiscal impact to provide education to judges and court staff but that this could be absorbed within existing resources.

The State Treasurer did not provide a fiscal note in the allotted timeframes.
