Examples of some changes include, but are not limited to:

- Allowing political subdivisions to utilize electronic forms when publishing code changes;
- Allowing metropolitan utilities districts to create gas main and other utility districts; and,
- Defines “Chief Executive Officer: for the Municipal Initiative and Referendum Act.

In addition to these changes, LB 163 outright repeals the sections of stature establishing the Municipal Infrastructure Redevelopment Fund Act.
