LB397 prohibits certain causes of action by motorists without insurance and requires the Department of Motor Vehicles (DMV) to establish (by July 1, 2025) and maintain an online verification system for certain entities to access motor vehicle insurance information.

The DMV has an online verification system in place that can have user access expanded to meet the requirements of section 2. As such, there is no fiscal impact for the Department of Motor Vehicles.

The Department of Insurance indicates there is no fiscal impact.
