**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

Municipalities and other political subdivisions are subject to a “lid” which limits the amount by which budgets (spending) can be increased. Section 13-520 lists those items that are outside the restricted funds limitations (or outside the “lid”) and therefore those items do not count toward the budget limits imposed by the Budget Act. The intent of LB345 is to add ‘restricted funds pledged to retire debt associated with direct borrowing’ to that list of exempted funds. This bill may be helpful to municipalities and their budgets, but are expected to have no impact to the state’s general fund appropriations.
