Explanation of Estimate:

The proposed legislation would change the appointment of Commissioners by the Governor to a statewide election process beginning in 2022. Terms of the newly elected Commissioners would begin January 15, 2023. Terms for those Commissioners in even-numbered districts and the at-large member would be 4-years. Those in odd-numbered districts would be 2-years and their successors 4-years.

No fiscal impact is anticipated.
