Explanation of Estimate:

LB 749 prohibits possession of deadly weapons in the State Capitol or on State Capitol grounds. The bill could increase the number of persons in prison. The specific amount of impact is indeterminable.

As of December 2022, the average daily prison population (ADP) was 147% of design capacity. The FY22 per diem cost was \$28.38 for each inmate, or \$10,358.63 per year.
