Explanation of Estimate:

LB34 provides for a presumption of disposition under the Nebraska Juvenile Code for crimes committed by defendants under eighteen years of age and changes the definition of juvenile under the code. The bill could reduce the number of persons in prison. The specific amount of impact is indeterminable.

As of December 2022, the average daily prison population (ADP) was 147% of design capacity. The FY22 per diem cost was \$28.38 for each inmate, or \$10,358.63 per year.
