LB 150 seeks to amend provisions in the Nebraska Liquor Control Act. The bill would make changes to when consumption of alcoholic liquor in the commons area could occur regarding entertainment districts. The bill would change the definition of commons area so that the definition would be separated into two categories as following:

- Cities of a primary class or cities of the metropolitan class
- Cities of the first class, cities of the second class, counties, or villages

The Nebraska Liquor Control Commission estimates no fiscal impact as a result of this bill. There is no basis to disagree with this estimate.
