LB 9 amends provisions of the Nebraska Political Accountability and Disclosure Act. The bill defines “Electioneering Communication” and requires any person, other than a committee, who makes an electioneering communication in an amount of more than one thousand dollars to file a report with the Nebraska Accountability and Disclosure Commission (NADC) within two days.

The NADC will need to create, modify, and reprint certain forms and fliers. They estimate the cost of this to be \$5,700. This estimate appears to be reasonable.
