LB625 defines an autonomous vehicle. This bill also provides a requirement that such a vehicle cannot be operated on any highway without the physical presence of a person who holds a valid operator's license. This person must be able to monitor the autonomous vehicle's performance and operate the autonomous vehicle.

The Department of Motor Vehicles (NDMV) and the Nebraska Department of Transportation (NDOT) have both indicated no fiscal impact from LB625.

We concur with no fiscal impact.
