LB 959 proposes amendments to section 29-1816 of the Revised Statutes. It focuses on the transfer of cases to juvenile court. The bill mandates that if a county or district court does not rule on a motion to transfer a case to juvenile court within 30 days after the hearing, the case will be automatically transferred.

Additionally, the bill aims to eliminate outdated provisions, harmonize existing laws, and repeal the original section 29-1816.

Expenditures:

The Supreme Court states that there would be minimal fiscal impact to provide judicial education.
