**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 1162 would clarify the law for county sheriffs to collect mileage fees when serving civil process using a county vehicle. These changes reflect current practice.

Currently, county sheriff departments typically use county vehicles to serve process and perform similar duties. As these duties are performed, the sheriff's department is reimbursed for their mileage by the entity hiring them for the services performed. The sheriff's departments then return the mileage fees to their local general fund. Current statute is not written this way, so LB 1162 intends to amend sections 23-1112.01 and 33-117 to update statute to current practice. If LB 1162 does not pass, county sheriff departments could be subject to audit findings.

No fiscal impact.
