Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1357 addresses camping on property owned or controlled by political subdivisions. The bill seeks to make it unlawful to knowingly camp on such properties unless they are designated as campsites. It defines "camping" as temporary lodging outdoors in shelters like sleeping bags, tents, or similar structures. Violations of this bill would be considered a Class III misdemeanor, and offenders could be ordered to reimburse the political subdivision for any property damage resulting from the violation.

The Supreme Court would have minimal fiscal impact to provide judicial education.
