LB 1343 amends provisions related to the Office of the Inspector General of Nebraska Child Welfare and the Office of Inspector General of the Nebraska Correctional System. The bill amends provisions related to appointment of the Inspectors General to allow appointment by the Executive Board, rather than the Public Counsel, and eliminates the five-year terms of appointment for each Inspector General position.
