Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 54 requires the Attorney General to designate a district attorney beginning January 1, 2026 to serve as the county attorney for criminal matters and juvenile court matters for each of the covered counties within the district. The Attorney General may assign additional deputy district attorneys and support staff to each district attorney as necessary to handle the workload in the district. "Covered count" is defined as a county with a population of less than one hundred thousand inhabitants. All district attorneys, deputy district attorneys, and staff assigned by the Attorney General shall be full-time employees of the office of the Attorney General and shall not engage in the private practice of law.

At this time, the number of district attorneys, deputy district attorneys, and staff cannot be determined. According to the Attorney General, twelve (12) districts would require staffing. It is assumed that any funding will come from the General Fund.

The Nebraska Association of County Officials (NACO) estimates cost savings of approximately \$9,100,000 for county attorney and deputy county attorney salaries. This estimate does not include other staff.
